

You know, it may be old age, it may just simply be that a good time is easier to come for me, but dadgumit, things went pretty good at HH 87. And while HH priors have suffered a rather gentle decline, it is my understanding that this year was up in attendance. I certainly think that the flea market went well and I even came back for the Sunday morning market and even bought some items. I also came back for the athletic contest between Louis KD5WA and Mac K2GKK.

One nice thing about writing articles for the C & E, you get to pick your hours and your tasks. You don't have to really listen to anybody and you don't usually get asked to do anything. At least, until this year. But, it is a labor of love and when I was asked to talk on Friday night, I agreed although I was just a little skeptical about the number of people who would show up on Friday nite, first, and to listen to me, second. Surprisingly, the crowd was decent in size, if even just a little unruly. But, I like them that way. It makes for a more sporting event.

people who were wandering around on friday night. And not just the usual sidewalk superintendents. I had a couple of things that kept me in the office until right before I had to dash out and scoot to the City, so I missed any preliminary activity before my talk. I did catch the tail end of the talk on Oklahoma weather. Boy, I am glad that I don't have to read that chart. At least without the 300 page instruction manual. Having missed the

first part of the meeting, I am sure I would ruin it for all of you if I reveal the end. Besides, I stared at the chart for several minutes since I was sitting at the very end of the room and it terminated its tour around the room at my station. Well, maybe I can catch the summer rerun.

The crowd was pretty active. It is always nice to have some kibitzers. come and gone and I have nothing The time passed fairly quickly and I think that many people realized that tower construction starts with neighborhood diplomacy. I strongly suggest it. By the way, don't put up a tower that looks like a piece of crap. And keep it off the right of way. You are aching for somebody to come along and reclaim it in the name of the city. I guess what I am saying is that if you want to put up a tower, put up something that is sturdy and solid and beyond argument as to its safety. You do no favors for yourself or anybody else when you put up a tower that immediately begins like with a 15 degree list to the south. I call these Notre Dame antennas (Because they have a south bend).

You may also expect that as many of the cities and townships become more sophisticated in their efforts to control "antenna polution" that they will begin to carefully select and use extra specifications to ensure "safety" of the tower. Now, there is no excuse for not building a safe tower. But, for example, if the normal wind loading is based upon 85 mph winds, it is unreasonable and in fact, arguably a denial of equal protection to insist that antenna support structures be rated at 100 or 150 mph. Some cities have adopted ordinances or placed restrictions that the tower cannot be taller than one-half the lot size across so that no portion of the I was surprized at the number of tower will fall on somebody else's yard. What is curious is that they don't make the same restriction for a house and there is in general, no reason to make the same restriction for a tower. A properly guyed and placed tower can fall entirely on a lot size smaller than its height, even in extreme winds. But the trick is that proper construction will insure that it remains in place through the first year. Regular and periodic inspection for worn components will ensure that it remains in place.

I guess I mention these factors now because I was driving through central Oklahoma City this past month and spied an antenna installation that made me cringe. The person had put up about 4 sections of tower, then put a crooked pole through the top for about another 20 foot. It was poorly guyed and there were various antennas hanging off the tower and a dipole tied off from the top. The ends were drooped off the property and tied off on some street sign. I presume that permission was obtained from the neighbor to cross the property, but I would bet that the city did not approve the tie off point. Of course, if this was a temporary installation, then there might be a valid excuse for not tieing up all the ribbons and tidying up, but it still was a little unsavory.

Another point for bad form is rusty tower. Or at least, tower that appears to be rusty. I prefer the galvanized tower with no paint. It seems to weather better. But for those of you who have steel towers, then spruce them up with a little paint every now or then. I use a heavy piece of oilfield tubing as the mast for holding my beam. It was a little rusty when I got it, so I sanded it a little and applied some rustoleum primer and black paint. It scratched up when placing it in the top section and sliding it up and down while installing the two meter and 450 antenna, but it still looks pretty good from the ground.

Also make sure that you don't have any broken cables, wires or ropes flogging about in the breeze. For some people, a broken wire is assumed to have electricity and is dangerous. A broken rope is something that has already fallen off and can probably be found at the base of the tower. More importantly, it suggests that other things held to the tower with rope are probably also on the verge of breaking. I guess what I am trying to say, for goodness sakes, don't let the antenna farm look like the shack. The neighbors are in enough of an uproar with even a proper antenna installation. My experience has been that some neighbors won't mind a proper installation and looks and stays safe. Others won't like anyting you

put up, so don't give them anything to really moan and complain about. There is a rule of reason here also. If you have a small lot, then don't expect to become the king of 160 meters. While Robert Browning said his grasp, " he was not talking about a moonbounce array on an apartment building. You want extravagent antennas, move to the country. But if you are like me and a city dweller, you can still do fairly well with antennas in the city.

Meanwhile, back at Ham Holiday. The program committee got rid of the mundane tower programs the zones of protection. on friday night, but Saturday morning they pulled off an achievement that not even Dayton has been able to accomplish. They selected and presented a program that did two things. First, it sent me to a program when I usually don't attend programs. The only programs I attend at Dayton are those that I have spoken at. Second, and most importantly, the program committee got me out of the flea market. In fact, for the first time ever that I have attended a hamfest, I went to a program before I went to the fleamarket. It takes an unusual program and an especially interesting program with a person who has something interesting to talk about. Dave Rust, from the National Severe Storms Laboratory spoke about Lightning. There is a man who can work in his chosen field for the rest of his life, even if he lives to be a thousand years old. Not many people can say that. Lightning is such a complex and fascinating subject and although much has been learned over that last several years that the project on lightning has been around, there is still so much unknown, that it might literally take a thousand years to find out everything. And what is even better, the government will always be willing to pay scientists like Dave to investigate lighting, or they should. The cost in terms of lives and property loss on a yearly basis makes lightning an appropirate subject for study for a long time.

So, I would say that Dr. Dave has plenty of job security. I have studied lightning in a general fashion for my own interest and for a couple of articles that I have written for the C & E. Needless, to say, I was relieved to see that I did not that "A man's reach should exceed embarass myself too badly in what I wrote. Lightning propagates in segments and because it does, some of the older rules about cone of protection from lightning rods have to be modified to a spherical ball That is, you must first imagine a ball 300 feet in diameter. Roll that ball over a surface and everything that is inside the ball is capable of being hit by lightning. Everything under the ball lies in

> Dave also presides over a network of lightning detectors that pinpoint the location of lightning strokes by triangulation by measuring the time difference that it takes a a radio wave from the stroke to pass by two antennas. By calculating basis. the difference and using a little fancy vector footwork and some number crunching, you can derive an angle of the lightning stroke with reference to the plane of the two antennas. If you use a couple of these antenna sights, you can triangulate the location of a stroke. They have got a bunch of them on tape. Have a lightning bolt scare you some night? Well, I don't know if the they take requests at the NSSL, but they might be able to find the bolt somewhere close to you if you have the time and location. #### The DR-200 Packet Switch

Since last month, I got my hands on some toys to write about. There has been a lot of talk on packet radio about networking, about the NET/ROM sold by Software 2000, TEXNET which is "real soon now", the COSI code that has not become available yet, the TCP/IP that is supposed to tie all these different kinds of things together and KISS, the TNC code that makes the TNCs more "computer friendly". (See the March and June issues of C&E about descriptions of some of these networking schemes.)

Bob, WB5AOH, was there and he brought a little TEXNET node consisting of an EPROM modified TNC-2 that can handle up to four circuit routings. He had it in his car and demonstrated it to us. Bob, also has a PacComm DR-200, dual port digipeater at his home in Fort Gibson and he shared his experiences with it. All in all, we got to survey many of the digipeater operators and talk about what they thought we ought to do next.

We have had a network scheme since digipeaters were incorporated in the AX.25 specification now but it hasn't been a very good performer. Connecting to distant stations through digipeaters gets the ends connected together but performance suffers because of two major problems. 1. When more than 4 digipeaters are used, the reliability goes to nearly zero. 2. When the same frequency is used in widely separated areas, the digipeater in the center gets all messed up with

collisions. (This is the "Hidden transmitter syndrome".)

The packeteros at Ham Holiday felt compelled to "do something". NET-/ROM is really the only automatic network routing scheme currently available, though TEXNET can be implemented on a small scale as WB5AOH has done, and TPRS is beginning to distribute circuit boards for the full TEXNET implementation. NET/ROM consists of an EPROM for either a TNC-2 design or an AEA PK-87. Several hundred have been sold for various areas of the country but the configuration of our current digipeaters is such that it is not easily implemented here. We have quite an assortment of Kantronics and TAPR TNC-ls located in key places so NET/ROM installation would require buying TNCs as well as the EPROM. There is also a bit of uncertainty involved with buying a proprietary networking scheme. But, we wanted to "do something" so we did.

The morning after Ham Holiday ended, I phoned in an order for four Pac-Comm DR-200, dual port digipeaters and received them the following Friday. I had an air conditioning failure at home so we didn't get them functioning until about the middle of the next week. Two of the units came assembled and tested and two of them were kits. I built one of the kits, taking maybe 8 hours doing so and then spent the next two evenings hunting for the reason why it wouldn't work. I was forced to drag a scope home from work to see what lines were shorted to what. It probably only took about ten minutes to find that a feed-through was too close to a trace and the etching hadn't separated them. (The second kit, belonging to WASFLT, had the same fault. Saved Joe some grief on that one, I think.)

In the mean time, I programmed two of them and we had them on the air. Bob-Robert, WA5BQX, the owner of one of the DR-200s christened his "CHN", for Chandler, its eventual home. I named mine "MWC1", though I don't know where it's eventual home will be. (They ID with regular calls.)

Before we go any further, I need to describe the DR-200 a bit. It is a dual port digipeater. You can connect two radios to it and they each have individual digipeater calls. For example, Bob's primary port has WA5BQX-3 and the secondary port has WA5BQX-4. These calls are only used to digipeat, like we always have. The DR-200 has a "global call" which is used for its switch function. (A switch, in telephone networks, is the equipment that connects various circuits together, like in a central

office or a toll office. The term "switch" is used to describe the operation of the DR-200, and the other network devices becoming available. You connect to it, it connects to the next switch, and so on, making up a circuit. Packets are acknowledged from switch to switch instead of from end to end, as they are with digipeating.)

To use the DR-200 as a switch, you connect to its global call. You connect to Bob's with "connect chn", and your TNC responds with "\*\*\* CONNECTED to CHN". The switch then sends a couple of packets that say something like "Switch Ready" and "Type HElp for commands." It then sends a splat (\*) as a prompt. At this point, you are at the command prompt of the switch. With the currently available software, there is very little you can do except to make it connect to another station. connect to a station with the alternate port, give you a list of stations it has heard lately or disconnect.

The commands are:

HE (help) Shows commands.

C Connect to a station using the same port you came in on.

CA Connect to a station using the alternate port.

RX Give a list of the most recently heard stations.

- SW Give a bunch of gobbledygook that is meaningless unless you are checking switch status and want to know about buffer utilization and other esoteric stuff.
- BY (Bye) Disconnect from the switch.

Once you have the splat prompt and you want to connect to another switch, you issue a command like "C MWC1". Since the two switches are in the same town, things start getting lively on the frequency. CHN issues a connect to MWC1 and sends a packet to it that says "\*\*\* LINKED to CHN". Meanwhile, CHN tells you that it succeeded in making the connection by saying "Switch: Connected". (Another patch. It originally said \*\*\* pad: connection reset". I didn't like that.) When MWC1 gets the connect from CHN it sends the same "Switch Ready", etc. stuff to CHN. CHN, in turn, sends this stuff to you. With the delivered code, in response to the "\*\*\* LINKED to CHN" message, HWC1, thinking it is an invalid command, was sending back "ERR". I patched that out of it so it sends back "\*\*\* LINKED to MWC1" You see that too. If you have your monitor while connected on, you see a mess. If you have MCON OFF, it looks pretty neat, though a lot of packets have been

flying around. Mac, K2GKK, observed that the presence of the switches has added a lots of extra packets that weren't around before. Right on!

On your screen, if you have MON OFF, it looks like this:

(you typed this) cmd:c chn \*\*\* CONNECTED to CHN (your TNC sent this to you, and maybe the time) (CHN sent this) Switch Ready Type HElp for help (CHN sent the splat and \*c mwcl you typed the "c mwcl") \*\*\* Switch: Connected (CHN sent this) (MWCl sent this) Switch Ready Type HElp for help \*\*\*\* LINKED to MWC1 (MWC1 sent a splat and then the rest of the linked message) \*c wa5bqx (splat was from MWCl, you typed the connect message) \*\*\* Switch: Connected (MNC1 sent this. You know you are connected. You are now in the converse mode with WA5BQX.)

If you issue a connect command and it doesn't seem to be making it, you can just send a carriage return and it will quit trying to connect and send a response "Aborted" followed by the splat command prompt.

If the station on the other end disconnects, the switch to which he was connected sends a packet, "\*\*\* pad: call cleared" and the splat prompt to you. (I ought to change that too. "PAD" is a packet assembler-disassembler, by the way. It is the term used in the telephone biz for the thing we call a TNC.) If you disconnect, the switch to which you are connected simply disconnects from you and sends disconnects to the rest of the switches and the station in the circuit.

If you are at the command prompt of the second switch, you can tell it to connect to a third switch, if it can reach one. For test, I issued a command "c ict wb5rrr-l" to connect to the Wichita, KS switch via the WB5RRR-l digipeater in Pond Creek. Notice that I didn't use the "via" or "v". This is the style of the WA8DED TNC code. Incidentally, the number of digipeaters that can be used this way is limited to 3 or 4. Remember, we are trying to get away from that kludge.

In any case, the ultimate purpose is to connect to another individual's station so the last command to a switch is to connect to that individual's station. All subsequent packets to that individual are sent from switch to switch and acknowledged at each link. I tested it by dumping a file to the WASBQX,

through both of the switches and it queued up in each switch as it was being passed to him. At the time there were other signals on the air and some collisions but the whole thing made it intact OK.

There are some problems with this method. First, you have to make up the circuit, switch by switch. It is a trivial job for a computer running an terminal program capable of interactive macros. They have to recognize connection successes and failures to issue all the appropriate commands or report a circuit failure. Anyone interested in doing this should get with me and I will give them the key specifications of success/failure indications at each switch.

There are some bugs and problems but there is not room to cover them this month. We will pick it up next month, possibly with some solutions.

Mechanically, the DR-200 is a Z-80 based device with 32K of EPROM, 32K of battery backed RAM, an 8530 SCC (serial communications controller) dual serial device, capable of synchronous and asynchronous operation, and dual 7910 modems. Data baud rates are independently programmab-1e. (Tone shifts are hardware jumper programmable so it can be used on HF as well as UHF/VHF.) The DR-200 is programmed with an accessory adapter that plugs into a header on the board, temporarily using one of the 8350's channels. When the switch is reset, it starts a prompting routine, at 1200 BPS, asking for global call, each port's call, an ID text for each port, and some other supervisory information. After all the information is entered, the accessory adapter is removed. some jumpers replaced on the header, and the thing buttoned up. We programmed the information in the EPROM so we wouldn't have to worry about the lithium battery going south, or anything getting messed up in RAM while the switch was installed at Chandler, While I was Munging (mashing until no good) the code, I couldn't resist fixing the problem that was causing the "ERR" when two switches connected.


The code was written by Howie Goldstein, N2WX, the fella who wrote the
TNC-2 code. It looks he used a
compiler of some kind because there
is a lot of code, approximately 30K
worth, which is a lot for a device
that does no more than this switch
does. I have disassembled it but
the commented and labeled disassembly is about 470 million characters
long! Needless to say, I haven't
carefully examined all of it yet. I
don't know what kinds of functions
might be lurking in there. In the

January - February 1987 Packet Radio Magazine, in the FADCA section, Howie mentioned this version of the code would be similar to the "roundtable" code, but without the roundtable. It is not intended to have any Level three (network layer) features and it is not intended for daisy chaining switches like we are doing. It is copyrighted, by the way. The PacComm literature does contain some set-up information for the 8530 but it would take a hardened process control programmer, starting from scratch, preferably using assembly language, to develop different code for this thing to make it effective as an automatic routing switch like used in NET/ROM and TEXNET. I have neither the wherewithal, nor ambition to tackle it. (This week anyway!)

The main purpose for getting the DR-200 switches was to provide a low risk way to do some on-the-air tinkering of a different type of packet protocol. As soon as the equipment proves itself, Bob-Robert is planning on installing his switch on the Chandler digipeater. It will still function as a digipeater using the alias "CHN" or the call WA5BQX-3. To be most effective it should be used as a switch though. From the Chandler location it should be able to hit the WB5AOH-12 switch in Fort Gibson. What Bob does with that switch, only Bob would know, but his switch will easily connect with his TEXNET switch, since it is on the same premises. The other switches will either be installed on existing or new digipeaters accessible by CH'I, or maybe set up on another frequency like 145.05 and 145.09.

There is already talk of linking the DR-200 switches with UHF. A user on 2H would connect with the switch and issue the CA command to make a connection on UHF to another switch. At the next switch he could either continue the link to another switch or do a CA command to come out on that switch's VHF port. For example, connect with CHN on 2M, do a "CA WB5AOH-12" then do a CA WB5TTU MCL to connect to Ron in Hugo through the MCL digipeater. Ron is going to want to do something with MCL, by the way. He will either go NET/ROM or the DR-200, depending on the success we have with the things or the progress made in Arkansas with NET/ROM.

Dave, WB5FME, has installed one of the switches, "OU" in Norman and has it running on .01 and .05. He and I will be doing some UHF experiments by the time you read this. For the full text of this article and for next month's conclusion, check the K5JB BBS on 146.415. (Conclusion next month) Joe, K5JB


