In the absence of the President, Ted NY5W, Doug W0DXA, called the meeting to order at 7:28 pm.


There were sixteen members involved in the round of self introduction.

OKLAHOMA CALL-LETTER LICENSE PLATE INFORMATION UPDATE

Joe McDonald, W5CCV, who as in on the original application for 'Ham Plates' has provided the following update information.

At the time this was signed into law by then-Governor Raymond Gary, the application was in two parts, the first of which was to have been completed and mailed before October 1. The second part was to have been completed and mailed to OTC after the regular-tag fee had been paid for the incoming tax-year of the vehicle-registration.

Present application form #718 R 90 provides:

- Any person holding a valid operator's license, conditional class or better, issued by the FCC, who is also the owner of a vehicle currently registered in Oklahoma, in which has been installed amateur transmitting and receiving equipment, shall be entitled to two (2) special vehicle identification plates as herein provided.
- 2. You are required to purchase the yearly decal during the month indicated on the current plate in order to keep your vehicle currently registered in Oklahoma. This decal should be permanently attached to the regular plate. Failure to purchase the regular plate in a timely manner will result in a penalty.
- 3. In order to display your Amateur Radio plates each year, you will need to make application to the Motor Vehicle Division for renewal. To insure that you receive a renewal application each year, please notify the Motor Vehicle Division of any address change.
- 4. Amateur Radio plates will be issued on a calendar year basis. They will be available approximately 3 months after the application has been accepted. Oklahoma Statutes state that these plates will expire the end of December each year regardless of the date of application. Applications will be accepted at any time during the year, however, the fee cannot be prorated for partial year use.

Fee: \$2.00. Drivers license number must appear on check. Mail application and fee to:

The regular license plate should be carried in the vehicle at all times.

Applications might be available through any tag agent, a request to OTC will be honored.

For the "First Timers", complete information is given on the application form.

FCC Levies Fines in 20m Mess

FCC FINES THREE AMATEURS FOR VIOLATIONS ON TWENTY METERS

The following enforcement actions have been taken by the Commission's Field Operations Bureau:

- -- William N. Terrill K1BFI, of New Hartford, New York, was issued a notice of apparent Liability to Monetary Forfeiture (NAL) in the amount of \$1000 citing violation of Section 97.101(d) of the Commision's Rules for willful interference.
- -- Herbert Schoenbohm, KV4FZ, of Christiansted, Virgin Islands, was issued an NAL in the amount of \$1000 citing violation of Section 97.101(d) of the Commission's Rules for willful interference.
- -- Richard K. Eastman, N5FX, of Springdale Arkansas, was issued an NAL in the amount of \$1,000 citing violation of Section 97.101(d) of the Commission's Rules for willful interference.

Business on Ham Radio

The following was pointed to by Dave, WB5FWE, who thought it would bear repeating. It was posted by Lynn, WB6UUT, who sells a commercial packet program and was responding to criticism for mentioning it in a packet message.

The current version of Part 97 came about as part of a comprehensive rewrite which was intended to reduce the total number and "size" of the rules, codify many of the rulings released over the years and clarify a number of issues. These rules became effective in September, 1989, and if you do not have a copy of these rules, you don't have a copy of THE RULES.

The section in question is 97.113(a) which states:

"No amateur station shall transmit any communication the purpose of which is to facilitate the business or commercial affairs of any party. No station shall transmit communications as an alternative to other authorized radio services, except as necessary to provide emergency communications. A station may, however transmit communications to:

"(1) Facilitate the public's safe observation of, or safe participation in, a parade, race, marathon or similar public gathering....

(The rest of this section deals with what is allowed and disallowed for various events of this type)

"(2) Inform other amateur operators of the availability of apparatus normally used in an amateur station, including such apparatus for sale or trade. This exception is not authorized to any person seeking to derive a profit by buying or selling such apparatus on a regular basis."

The key section is 97.113(a)(2) which specifically allows the discussion of commercial items, and no mention is made of prices, giving the name of the vendor, places where these items can be purchased, etc.

The only requirements are that the item must be for use in an AMATEUR station and that the party sending the message can't profit by selling such equipment on a regular basis. (i.e. either as a producer or seller of amateur gear, or by buying at a swapmeet and selling on a very regular basis). 73, Lynn, WB6UUT

CONSTITUTION/BY-LAWS

As I have been able to briefly discus to the membership in the last two meetings, certain amendments to the OCAPA Constitution and By-Laws are in order to clarify certain passages, and to insure clear understanding of the written law of the constitution and the by-laws as specifically intended.

Article V of the Constitution, and Section X of the By-Laws provides that members receive twenty-eight (28) days prior notice of said amendment(s).

There are three (3) proposed amendments: BE PROPOSED THAT the Constitution of the Oklahoma City Autopatch Association, Inc., Article III, Section 3, BE AMENDED FROM: A members spouse dependents under the age of 18, residing in the same household, having a valid Amateur license will automatically become a member of OCAPA with full membership privileges upon registration with the Treasurer, BE -AMENDED TO: A members spouse and/or dependents under the age of 18, residing in the same household, having a Valid F.C.C. Radio issued Amateur license will automatically become a full member of OCAPA with full membership privileges upon registration with the Treasurer.

2. BE PROPOSED THAT the By-Laws of the Oklahoma City Autopatch Association, Inc., Section X, BE AMENDED FROM: These by-laws may be amended when approved by a majority of the members present at a regular meting, provided that members receive twenty-eight (28) days prior notice of said amendment. BE AMENDED TO: These by-laws may be amended when approved by a majority of the members present at a regular duly constituted meeting, provided that members receive twenty-eight (28) days prior notice of said amendment.

3. BE PROPOSED THAT the By-Las of the Oklahoma City Autopatch Association, Inc., Section XI, BE AMENDED FROM: These by-laws shall be adopted and become effective as the by-laws of OCAPA when they have received a two-thirds (2/3) acceptance of he members present at a regularly constituted meeting, provided that members have received prior notice. BE AMENDED TO: These by-laws shall be adopted and become effective as the by-laws of OCAPA when they shall have received a two-thirds (2/3) acceptance of the members present at a regular duly constituted meeting, provided that members have received prior notice.

These proposed amendments will be introduced at the November meeting.

QST This is an announcement to ALL hams. It's good for things like SKYWATCH & other public stuff.

BEACON My TNC is in the automatic mode. I'm NOT at the keyboard. This is for use on mailboxes and digi's.

MAIL Mail posted for....This is for BBS use,

NODES THESE nodes have been heard by THIS node:(Nodes only.)

ID Meaning of this one should be obvious. It is for use by Nodes, Digipeaters, BBS's, Clusters, etc.

NOCALL The Lid running this TNC neglected to put his callsign in using the MYCALL command.

PLEASE don't leave your BEACON UNPROTO set to CQ, even if you are sitting at your keyboard waiting for a live QSO to happen. Choose an appropriate UNPROTO address you have chosen for your TNC, i.e., "BEACON VIA W1ABC, W0XYZ" for your mailbox, etc.

Also, don't beacon TOO often. Every 20 minutes is MAXIMUM! You'll soon notice that SOME stations beacon every 3 to 5 minutes. Nothing will get you a reputation as a packet LID any faster! DON'T use BEACON function to send CQ's. Do it manually from the keyboard.

PK-232 OWNERS, PLEASE NOTE Try these settings on your TNC the next time you are hunting for live QSO's.

MFROM NONE MTO YES CQ MBELL ON

Now, everytime someone sends a CQ, your terminal will ring three bells to alert you. But be forewarned, PLENTY of folks are still using "CQ" as their BEACON, when they are REALLY out to lunch. Change the MTO to MAIL and your terminal call will call you the next time the MAIL LIST is transmitted. This way, you'll be able to see if you have any mail without having to connect to the Mailbox or BBS.


You can easily set up your TNC so only what YOU want to see will be displayed onscreen. For example:


