# Happenings on Packet

The ARRL Digital Committee created somewhat of a firestorm this month when it submitted its report regarding the Station Temporary Authorization (STA) for packet stations to operate unattended on high frequency. The full text of the report is pretty long so it is probably not available on packet bulletin boards but if you can't find it anywhere, I can make it available over phone modem or FTP via TCP/IP. The crucial recommendation that created

such an adverse reaction was that automatic operation not be permitted on HF.

Immediately, articulate writers flooded the packet circuits with well crafted slings and arrows. They attacked the basis of the recommendation and pointed out that elimination of automatic operation would essentially stop crosscountry forwarding of bulletins and messages.

The detractors are more factually correct than the digital committee authors and did a much better job of expressing their points, but there is a dilemma here that would take Solomon to solve.

People in amateur radio are no different than people anywhere else, and many of them think that they have basic "rights" to do whatever they want, regardless of the effect on common cause. The STA worked well because it only permitted selected people, who committed to perform a public service, to operate their stations automatically. Any "Me Too!" types were prevented to put self-serving bulletin board stations on the air because it simply wasn't legal. This "artificial" restriction had the effect of permitting the BBS stations to operate in a coordinated manner, without slopping all over the HF spectrum and preempting other users of the spectrum.

Now comes the ARRL Digital Committee to look at things and make a recommendation. The STA had been re-issued several times and the FCC wasn't going to re-issue it next January (I believe is the date). The ARRL sought opinions on what amateurs thought should be done to accommodate digital modes on HF, and unfortunately there was no simple answer. If unattended operation was simply

permitted for anyone who wanted to do it, the results would have been chaos. The committee (after performing a survey and taking a simple count of hands) it formed an opinion that the average user didn't want to have automatic operation. The Committee came up with what it probably thought was a compromise. It recommended Semi-Automatic operation -- one station of a pair would have to be operated by a human. This is not really a compromise, but an end to automatic message forwarding.

What would have to be done, if anything is done to salvage the situation, is for someone to propose, and amateurs to accept, some kind of "value test" of a person's operating of an automatic station. If it had no redeeming value, it simply not would be permitted to operate automatically. The obstacle to this approach is that the vocal "equal rights pinkos" would never accept the concept of rewarding someone who has expended the effort to become qualified.

Not a large percentage of amateur radio operators use packet, much less take advantage of the cross country messaging capability it offers. Some observers, when they get into packet radio, are bound to be turned off by the apparent stupidity of operators who send asinine bulletins over the system (e.g. Monster bulletins that have nothing to do with amateur radio, or worse, broadcast bulletins to "ALLUSA" with a to field, "HELP" and a subject, "NEED HELP").

The opinions formed anyone who observes this kind of stuff is bound to have an adverse effect on a "popularity poll" like the one performed by the ARRL Committee. I don't know how digital messaging is going to survive this latest screwup! Joe, K5JB

SKIPPING THROUGH THE DEW. Recently Ken, W5QMJ, received a certificate from ARRL, entitled Samuel F.B. Morse Bicentennial Code Proficiency Award, for copying Morse code at 60 words per minute. Ken is as proud of that as he is for winning the left foot Morse code sending contest at Amarillo a few years ago. Ho hum.

Jack, K512H, is a high speed code man. As one scales the heights of proficiency, one begins to copy not just characters at a time, but whole words at a time. In Jack's case, he can copy entire sentences at a time. He used to simultaneously send\_two messages, one with his right hand and another with his left hand, while copying a third one in his head. On top of all that, he would be carrying on a conversation at the same time. I often wondered why he couldn't be doing something with his left foot all the while, until I discovered he is right footed, and was using that to pet his cat.
