





# The Adams Family, Alvin & Olive

Alvin L. Adams was born June 6, 1918. He was one of five children born to Benjamin H, and Bertha Connelly Adams. Alvin in his younger years was a good boy but he liked to have clean fun.

In his younger years of schooling he attended small schools like Fonda, Pumpkin Ridge, He graduated from Seiling High School. In high school he played football and basketball. Alvin never did tell how good he played, or brag about anything he did. He loved telling clean jokes, but no bragging. In high school Alvin was active in FFA.

Alvin's older brother had gotten married and moved to Canton to operate a service station -- now they are usually called gas stations, since they are mostly help yourself. No service makes the difference. That's what brought Alvin to Canton.

Olive L. Martin was born to Glen E. and Mary Mock Martin July 30, 1922, one of three children. Olive's family lived on an acreage. They owned and operated a chicken hatchery and had a green house that keep them busy. Olive went all twelve years through the Canton schools. Olive worked eight years for a gasoline wholesaler.

When Alvin came to Canton, Olive was working in her uncle's restaurant. That is where Alvin met her. They didn't say but there were indications that the sparks flew.

In September of 1941 Alvin was called to Oklahoma City for a physical. After the examination he went to Fort Sill and volunteered to enlist and go to Hawaii for his basic training. Alvin's group finished basic training December 6 1941 and moved out of the tents into the barracks. December 7, 1941 the tents were totally destroyed.

The Japanese had bombed Pearl Harbor.

Alvin returned to the States in May 1942 to go to a special school. He got a one week furlough in September and arrived at Canton September 12. That night Alvin and Olive were united in marriage.

Alvin went back to the Pacific in 1943 and got discharged in October of 1945. The couple bought a service station they operated until he was recalled in September 1950 for the Korean War. When they bought the station was when I met them.

The Adams sold the station and moved to Lawton, living there until he got discharged in May 1952. Then they started operating the concessions at Canton Lake.

Alvin contracted the Hodgkin's disease in 1970, selling the concession in 1975 but continued to farm and raise cattle. Alvin was a good manager. One time he talked his father into buying a tractor to let him and his brother do custom work for the neighbors to help pay for the tractor.

The Adams read an article in the Enid paper about a ham radio class. They both were interested and attended until Olive's mother had to go to the hospital. Winter came on them with bad roads so they had to drop out. Later Leo, WZ5H, and Ray, AB5Z, started an amateur class and Alvin and Olive started back and got their licenses.

Alvin, being a Pearl Harbor survivor, checked into the Pearl Harbor Survivors' Net. He liked to operate the HF frequencies and listened to 2 meters a lot, but seldom talked on 2. One day I asked him why he would talk on HF but seldom on 2 meters, and he responded with this joke: He said, "Well, Ralph, I will tell you but don't you ever tell Olive. See we only have one chair in the house and as soon as Olive eats her supper she hurries and gets the chair to talk on the radio. Now I have only one of two choices, either set on the floor, or go to bed, so I just go to bed and let her have it."

While Alvin and Olive were at the lake he had a heated fishing dock built, along with boat storage and trailer park. Alvin used to do commercial fishing in the winter to help improve fishing by removing some of the rough fish, mainly buffalo, which were seldom caught by fishermen.

All the years I have known Alvin he has never talked about his experiences or what he went through in the wars. I did not ask questions about that. I feel that if he wished to tell me about it he would have. I value their friendship very much.

# New Message Forwarding Rule

The FCC April 13 released a Report and Order in PR Docket 93-85, regarding message relay by amateur high speed networks. The new rule relieves most operators in such networks of responsibility for message content.

Originators of such type messages continue to be responsible for their content. The first forwarding stations are also responsible for the content of messages, or identity of the originating operator.

This rule goes into effect June 1, 1994. If you are a forwarding station I suggest that you read the complete rule.

### ARRL Fund to Foster Good Will

When Lloyd Colvin, W6KG, died last December, the League became the beneficiary of the proceeds of a life insurance policy on Mr. Colvin. The proceeds, more than \$150,000, will now fund an endowment. The income will be used to further the strengthening of international friendship through DXing.

ARRL Executive Vice President, David Sumner, K1ZZ, said, "During his lifetime, W6KG made great personal contributions to international friendship through amateur radio in the visits to more than 150 countries with his wife, Iris Colvin, W6QL. Through the Colvin award, the League will proudly continue those contributions."

# League Seeks Tighter Club Licensing Standards

The ARRL has petitioned the FCC to increase the minimum number from two to four members for granting a club station license. Reason is that two or three non-club members could make application just to get an alternate call sign. The FCC has designated the petition RM-8462. The FCC delayed action in the past; they have not issued a club license since 1979. In 1976 the FCC required a copy of the constitution and bylaws with the application.

A personal note: I am in favor of tighter regulations to keep a precious hobby legally clean.

# Hamvention Forum Features Ham-Astronauts WOORE, N5RAW

A space forum at the Dayton Hamvention was scheduled to feature two NASA astronaut-hams, Tony England, WOORE, and Steve Nagel, N5RAW. The forum will commemorate 10 years of amateur radio aboard the shuttles, which began with the flight of Owen Garriot, W5LFL, in November of 1983.

Tony England flew on the second ham radio mission, in 1985. Steve Nagel, a veteran of several shuttle flights, recently commanded shuttle flight STS-55 in 1993. The two will describe their amateur radio experiences from space and answer questions.

Also at the forum will be members of the ARRL SAREX working group. Now we know why WA5FLT went to Dayton -- to go on the next shuttle flight! Ha!

# Telephone Interference Survey Examined

ARRL Lab offers solutions to problems. In early March the Federal Communications Commission released statistics from a survey of 105 random cases of telephone interference, saying that since some telephones are bullet proof, all of them should be.

The results of the study were obtained by the ARRL and reported in May QST.

# New Mobile Tools for FCC Include 10 Computer Cars

The Federal Communications Commission is showing off a new vehicle for investigative work, equipped with two computers, a color monitor, a mobile phone, and a satellite receiver. The FCC told the Associated Press it expected to have 10 such cars in service in metropolitan areas this month, with the goal of eventually having two such cars for each of the Commission's 32 field offices. The FCC said that businesses and boat operators are more likely to operate unlicensed transmitters.

# FCC Turns Down Petitions for Changing Amateur Rules

In late April the FCC denied three petitions from amateurs to change the licensing structure. One petitioner would have lowered the Morse code requirements and two others would have eliminated the 5 wpm CW examination for the Novice license. The FCC said the current amateur license requirements were the results of Commission proceedings that produced thousands of comments. "The amateur community indicated on each occasion that it strongly desires to preserve communications by telegraphy," the FCC said.

# QST to make July Debut on Nation's Newsstands

Beginning in July, QST will be avail-

able at selected newsstands on an experimental basis. The newsstands will be identical to ARRL member's copies, but the covers will have a slightly different look.

### Is There a Problem?

# **HF Automatic Control**

ARRL Bulletin 51 From ARRL Headquarters Newington CT June 15, 1994 To all radio amateurs...

FCC proposes automatic control for amateur HF digital communications

In a notice of proposed rule making in PR Docket 94-59, adopted on June 13, 1994, the FCC has proposed amending the Amateur Service rules to authorize automatic control of stations transmitting a digital signal on the HF bands. The action had been requested in petitions filed by the ARRL and the American Digital Radio Society (ADRS).

In 1986, the FCC authorized automatic control of amateur stations transmitting digital communications on the VHF and higher frequency bands, and indicated that it was interested in authorizing such automatic control on the HF bands.

To determine solutions to the problem of interference from automatically

controlled HF digital stations, the ARRL conducted a feasibility project under Special Temporary Authority granted by the FCC to 50 amateur stations. The ARRL petition was based on the results of that study.

The FCC said that it was gratified by the cooperation and dedication of amateur organizations in determining the conditions necessary to allow automatic control of stations transmitting data and RTTY emission types on the HF bands. It agreed with the two petitioners that automatic control of amateur stations in the HF bands can, with safeguards, make the transmission of data and RTTY emission types both practical and effective.

Therefore, the FCC proposed to authorize automatic control for stations transmitting data and RTTY emission types on one specific subband of each HF band where such emissions are authorized. It also proposed to authorize communication between a locally or remotely controlled station and an automatically controlled station on any frequency where data and RTTY emission types are otherwise authorized.

The text of the NPRM has not yet been released, and the comment deadline is unknown at this time.

In response to the May article about the Internet, I got a note from Bill Conner, newsletter editor of the OkcForum Unix User's Group, advising me of its existence. He said the group's primary purpose was to offer Unix experience to its members but it's machine does have full Internet access. He didn't state when the next meeting was scheduled and there was insufficient time for him to respond to my query before I had to get this column in the mail. If you are interested in the group I

# I Only Know What I Read in the C&E

When I learned that Hal, KB1ZQ, had been appointed as editor of the C&E, I called him to start coordinating how to get material to him, and see if there was any technical assistance I could offer. There are about as many ways to put a newsletter together as you can imagine, but the first thing most people think of nowadays is to get some kind of computer, then get some kind of software, then figure out how to print it, then figure out what to print. This is really not the correct order of planning a newsletter, but that is the way people do things.

Maybe because I have 25 years of technical publication experience behind me, I know of a lots of ways to put out a rag. Joe, WA5ZNF, had a newspaper background, and he also knew a lot of ways to publish, and I think that he would agree that the first things to consider are what kinds of words are you going to publish, and who is the audience. Once that is decided, the mechanics of composing and printing are actually pretty trivial. My point is that if the clubs who constitute CORA don't pull the important part of the load -submitting timely and interesting things for publication, the C&E won't be worth much, no matter how fancy the computer, software, and printing process may be.

Hal apologized for having modest computer equipment, but there was no need for apology. I printed my submissions for years with an IBM Selectric typewriter that I had wired to an Apple II computer. The results were quite respectable, and the C&E won awards for appearance during that period.

The mechanics of getting material from the club editors to Hal can vary according to the capabilities of the individual editors. At one end of the scale, book paper. On the other end of the scale it can be sent electronically, already formatted, to Hal. Handwritten submission is almost foolproof. Electronic transmission is very problematic, unless everybody involved in the transfer is knowledgable of data communications methods, which is unlikely. (I do get a little bit of stuff via packet radio, and I can either print it, or hand it off to Hal in the format he needs. However, the vast majority of amateurs don't have access to packet radio.)

The middle ground would be to type camera-ready copy in column wide strips for Hal to paste up -- unlikely to succeed because of Hal's final composition methods; or, sending the material in ASCII text on a floppy, or electronically. Electronic transfer sounds the best, and I think Hal has chosen a word processor capable to do the composition that he wants to do, but I am afraid that depending on electronic transfer is an obstacle to the most important process: Putting the words together!

Another middle ground approach is one that I am taking. I compose full pages, print them and mail them to the editor. Since Hal lives close I may hand deliver them. Ralph, WA5PFK, and I worked out a deal last year at Ham Holiday. He types up his Wheatstraw club submission and mails it to me. I retype it, making occasional editorial changes to make it fit, and print his material while I am printing mine. I am a fairly fast typist, and am happy to do this for Ralph. I don't know what kind of workload I am looking at, but I would be glad to do it for any other club editor who had no fancy-dancy computer to play with but wanted to participate.

The main point is that CORA clubs need to appoint editors who will accept the responsibility, and at least send minutes of their meetings to someone, so they will appear in the C&E. If your club editor isn't doing his job, find someone in the club who will.





### ARRL Bulletin #56

### Look At Licenses!

Amateurs receiving new or modified FCC licenses after **June 8, 1994**, should carefully note the expiration date. Only new, first licenses or specific renewals have a full 10 year term.

Amateur license upgrades, changes of address, call sign, or name changes are processed with the original expiration date intact. That is, they are not automatically extended for 10 years.

The FCC using a new computer software recently installed, is processing amateur licenses in this manner to conform with the way it processes all other Private Radio Service licenses.

The FCC currently recommends that amateurs submit license renewal applications 60 to 90 days before their expiration date. The Commission said it intends eventually to mail license expiration notices to amateurs. In the meantime, the ARRL is sending license expiration notices to ARRL members, along with an FCC Form 610 and a return envelope to the FCC's licensing division in Gettysburg, Pennsylvania.

# Propagation Forecast Bulletin 28 ARLP028

From Tad Cook, KT7H Seattle, WA July 15, 1994 To all radio amateurs

The sunspot count was up a bit last week, but the solar flux was about the same as the week before. The Sunspot Number is based on the total area and number of spots visible on the solar surface from Earth. More sunspots of larger areas generallly produce more of the sort of radiation that makes the ionosphere reflective.

Solar flux is energy from the Sun measured here on Earth at 10.7 cm wavelength, or 2.8 GHz. It correlates fairly closely to the charged particles reaching the ionosphere that reflect radio waves.

Geomagnetic disturbances were down last week, with a falling A index in the single digit but on Thursday, the day this bulletin was written, the K indices began to rise to four. More active levels are forecast for the next couple of days due to a recurring coronal hole, an area on the Sun that generates disturbances here on Earth. Another period of upset is forecast for July 23 to 28.

Solar flux is expected to stay in the eighties through the rest of the month. Broad peaks around 90 may appear centered around July 19 and August 6. Sunspot Numbers from Julyl 7 through 13 were 90, 82, 72, 102, 84, and 81, with a mean of 86.1. 10.7 cm flux was 85.4, 85.8, 85.9, 86, 85.6, 82.9, and 81.4, with a mean of 85.1.

The path projection for this weekend is from Cleveland, Ohio to Congo.

80 meters should open from 0030 to 0515z, peaking around 0200. 40 meters should be good from 2330 to 0530, and 30 meters from 2230 to 0600. Check 20 meters from 2100 to 0230, and on some days, 17 meters may be open 0000 to 0200. 15 meters and above do not look look good at this time, but on rare occasions 15 meters may open just after sundown on the Cleveland end of the path.

If I read this right the bands should have some decent propagation. I placed this in the C&E to give an idea as to how the band conditions should be over the next month. If someone will sit down and write a layman's article on how to read the solar flux and sunspot numbers it would be appreciated. Help teach us how to read this type of information, so we can make more contacts.
