
Moving on to other subjects, elections are coming up this next month and we are looking for a good turnout to help us select a slate of officers.

# Joe Buswell, K5JB SK

It is my sad duty to report the death of a second amateur radio friend in the past week.

Joe Buswell, K5JB died this afternoon (Thursday, 29 Aug) around 1600. Funeral arrangements are currently incomplete, but whatever services are to be held will not occur until Tuesday, 3 September or later. I will provide the info as it is made available.

Joe was extremely active in many phases of amateur radio and most recently was truly an Oklahoma pioneer in the realm of packet and other digital forms of amateur communication. Joe was one of the very first (if not THE first) amateur on packet in the state of Oklahoma. He had run a Packet BBS on an old Apple 2 computer This was the FIRST for many years. packet BBS in Oklahoma. He was the state coordinator for TCP/IP addresses. He operated SEVERAL VHF and UHF packet and TCP/IP forwarding links and was one of the truly knowledgeable individuals regarding various versions of the NOS digital communications software programs.

Joe had been a mainstay for many years of the Oklahoma Traffic and Weather Net on 3900 kHz each weekday afternoon. He was similarly active on the Oklahoma Phone and Emergency Net which is conducted on the same frequency on Sunday mornings.

Joe and other "gurus" of digital communication within Oklahoma and some surrounding areas also had an informal info net on 3883 kHz every Saturday morning.

It was a week ago this morning that I received a call from Brad, KJ0W telling me of the passing of Chuck Whilhite, K5NK. My first concern was for his family and what had caused his sudden death. Then I started calling members of OCAPA to tell them that a friend had gone. By early afternoon, it was the main discussion on the 82 repeater.

Chuck was a part of the foundation of the OCAPA organization, as well as a stable voice of logic in CORA. I looked to him for guidance and as a friend.

Chuck, with the help of Don, NO5M helped me purchase my first HF rig, a Kenwood TS-520S. He told me that Don had a good reputation, and that the rig would be a good one. With the help of Mac, K2GKK, I learned to tune the tubes and make it work.

During Chuck's service, the minister said Chuck always had a hug for the girls. When my daughter, Shannon, KB5RBX got her ticket in 1991, he offered her assurance and encouragement. With his support, she sat up all night at Field Day '92 working CW (not bad for a Novice). He always wanted the latest update on her

music and her boyfriends. Chuck wasn't happy with her choice of college (OU) or with her last boyfriend, but he still loved her as if she were his granddaughter.

Saturday, the day before he died, Chuck and Sue spent the day working with the Heartland Search and Rescue team looking for a child that has been missing for several weeks. The Tuesday before that, he drove the train and blew the whistle during the OCAPA officer elections. He would meet me for lunch anywhere I was during the day.

Chuck was a master at putting up towers and antennas. It was under his leadership (we knew he was a leader, because he always had a cup of coffee in hand) that many towers were stacked or taken down. The only tower lost to a storm, that I remember, was the top sections of John, NJ1V's, but John had used a commercial tower crew to put it up. They should have listened to Chuck.

During Field Day '96, Chuck worked endlessly to make sure the group had food and a good time. With his coffee and his call, the group earned over 10,000 points this year.

Most folks will remember Chuck as the guy at Ham Holiday, giving away the prizes. At HH '94, he asked me to assist him with the drawings. At HH '95, as CORA president, he asked John, NJ1V and I to do the drawings. Boy, did I find out how much work that was to stand in front of nearly a thousand folks wanting the big prize. To this day, I haven't figured out how he got to park his red truck in the building.

In knowing Chuck nearly 6 years, I have seen him furious at the activities of a group in CORA. He was as proud as a new father when his wife and youngest son got their licenses. I have asked his advice on things about OCAPA. He always represented himself with confidence and dignity, even while eating dinner at Hooter's before the CORA meetings. I will always be proud to say that Chuck Whilhite was a good friend.

We became instant buddies! Chuck was the kind of guy you get to be "instant buddies" with.



After Leonard W5MEL passed away, Chuck used to tell me that after he retired he wanted to fill in for Leonard, being around during the day to talk to hams on our repeater that were just passing through town, or new hams needing help. Someone else needs to step up to that now.

As I said, I met and grew to know Chuck as a result of my good fortune in becoming interested in the hobby, and our common interest in ham radio. I never knew much about his non-ham radio activities, but I'm sure he was just as active in them as he was with his amateur radio interests. And I'm sure he was just as loved, and will be just as missed.

The eight-months pregnant Mary Anne Carter woke up on August 21 to discover Calena, her nine foot Burmese python, wrapped around her bulging stomach and nipping at her buttocks. Her husband, Brad Carter, grabbed a small knife and attempted to remove Calena from Mary Anne, but Calena managed to ensnare Brad as well. A neighbor arrived and tried to free them. He failed.

Than someone apparently had a brainstorm: call 911. Paramedics quickly arrived and hacked off Calena's head with a hacksaw. This did the trick, Mary Anne and Brad were free.

The Carters, who live in a one room apartment in a downtown residential motel, have two children—ages four and five, who witnessed their pet's attempt to kill their parents, then witnessed the paramedics' decapitation of their pet.

Police brought in crisis counselors to debrief the youngsters.

The case has been sent to the city attorney's office for review. San Diego does not forbid its citizens to keep large dangerous snakes as pets but, thanks to the Carters, this may soon change.

Tests are being scheduled to determine whether the snakebites affected the Carter's unborn baby.

And there we have it. The answer to the question do snakes make good pets and are they dangerous. I know this is not a typical article for the C&E and apologize to all that are offended by it.

I grew up catching horny toads and kept them over night but would release them in the morning, I would catch tad poles and keep them until they changed into toads. My dad and I would make the trip back to where we had caught them and I would release them. We even had a raccoon, rabbits, fish, a dog, cats, birds and yes a few snakes. # VANITY GATE 2 OPENS SEPT 23

This is a Newsline Instant Update.

Attention Extra Class hams. It will soon be your turn to file for the vanity call sign of your choice. This is because the FCC has announced that vanity call sign filing Gate 2 will open September 23rd.

After that date, Amateur Extra class licensees may request a vanity call sign of his or her choice on a first come first assigned basis. To qualify, you must hold an unexpired Amateur Extra class operator and primary station license to request a vanity call sign for your primary station.

To request a vanity call sign for a club station under Gate 2, you must also hold an unexpired club station license listing you as the license trustee.

Applicants should refer to the licensee database to verify that a requested call sign is not already assigned. According to the FCC, a call sign is normally assignable two years following license expiration, surrender, revocation, set aside, canceled, or on the verification of the death of the previous grantee.

Requests must be filed on FCC vanity call sign Form 610V and the Commission says that legibility is critical. If your application is not easy to read, you could experience a delay in processing. Even worse, you might lose the opportunity to obtain a requested call sign or even obtain a call sign different from what you want.

Again, Gate 2 of the vanity call sign program to permit Extra class hams their choice of a new call opens on September the 23rd.

It was recommended that participants attend regular storm spotters' seminars. The main need for such an activity stems from the fact that there appears to be no spotters between Choctaw and Shawnee. There being no genuine desire to pursue this activity, the topic was dropped.

RF Hazard Measurement: Don, N5ENQ informed us of new FCC RF Safety Standards that go into effect 1 January, 1997. This will require hams operating more than 50 watts PEP to conduct routine RF radiation evaluations to determine if RF fields are sufficient to cause human exposure to RF radiation hazards. Detailed information regarding

# PRSG FILES ON FAMILY RADIO SERVICE

General Mobile Radio Service users do not want to share spectrum with a newly created Family Radio Service that could be a nightmare to control and their lobby group is taking a point position in asking the FCC to enact some major rules changes. The Michigan based Personal Radio Steering Group filed a Petition for Reconsideration that contends that current FRS rules do not preclude repeaters, nor do they bar the transmission of music and other sound Also not covered is the effects. transmission of obscene or indecent language or issuing phony distress calls. The Personal Radio Steering Group believes that all of these prohibitions must be put in place and that the FCC must also place a strictly enforced time limit on all Family Radio Service transmissions. It also is asking that FRS users be required to monitor activity on a channel before transmitting.

# NOC-HSV

The small number of no-coders who attended a Newsline sponsored seminar session on code free licensing at the Huntsville Hamfest agree that its time to do away with the Morse code entirely. Most expressed the view that only two classes of license are really needed any longer. These would be limited time duration entry level where you either upgrade in two years or you are out. The other license would be a more advanced radio amateur with full high frequency operating privileges. Neither would require mandatory Morse code testing, but all agreed that higher written exam standards, with emphasis on proper on the air etiquette should be put in place.

# HUNTSVILLE UP

And speaking about the Huntsville Hamfest, manufacturers, dealers and distributors of ham radio equipment are hoping that the slight increase in attendance at last weekends event signals a nationwide change for the better. Since the first of the year, almost every convention and hamfest, big and small, has reported a significant decline in the numbers attending over past years. Even numbers at the giant Dayton Hamvention were down. This even though weather excellent. conditions This were downward spiral in attendance has made the ham radio industry very uneasy in committing to shows for next year.

But Huntsville was the exception. While still hovering around the 6000 mark in paid gate, the numbers were up a few percent over 1995. Scotty Neustadter, N4PYD, believes that Huntsville has bucked the downward trend because it has the right mix:

"I think its that we have the reputation as a friendly hamfest, with a very strong flea market and an all encompassing dealer show. I don't know how we could make the dealer show any bigger. Everybodys here. Anybodys product line is here. Plus I think frankly the town is the right size, the hotel rates are reasonable, the space and rocket center is here, so somebdy who is iffy about coming says I can

always drop the wife and kids at the space and rocket center while I go play with radios. And all that stuff just comes togather, I guest it is kind of synergistic that it works." Neustadter

For Huntsville it does work, and those in the commercial exhibit area like Evelyn Garrison, WS7A with Alinco agree:

"An excellent show. We sold a lot of HF units that people told us it was not going to happen down here. But it did. We sold a lot of the 605's dual band mobiles, which is our new radio. I'm really pleased." Garrison

Garrison also gives credit where she says credit is due:

"The committee really works at making this one up. They send out flyers. They work to make it happen all year long. It is not some think that happens by accident." Garrison

As positive as the signs were at Huntsville, two groups were very obvious by their failure to show up. These were the younger hams. The teens and preteens who, up until this year have been attending most conventions in fair numbers. Few were at Dayton in May. Even fewer were seen at Tulsa and Birmingham earlier in the year. Almost none were seen at Huntsville.

Even more significant was the failure of no-code Tech's to come out in any numbers.

# ARRL ASKS FCC FOR MORE TIME TO AMEND EXAMS

The ARRL has asked the FCC to extend the time for its VEC and other volunteer examiner coordinators to add questions about RF safety to Amateur Radio exams. The request, filed August 12th in the form of an emergency motion asks the Commission to put off the deadline to add the new exam questions to July 1, 1997 for Element 2 and 3A examinations and to July 1, 1998, for Element 3B examinations. Those dates coincide with the already planned implementation dates for new examinations based on revised question pools.

Work to revise the question pools for Elements 2 and 3A has been under way for more than a year. Work on the

Element 3B question pool will not begin until December.

The FCC Report and Order 96-326, issued August 1st, seemingly requires that VEC's immediately add five questions to each of the three affected examination elements. The provisions of the Report and Order became effective when they were published in the Federal Register on August 7th.

# OVERSEAS ACCUSATIONS REFUTED

From overseas, word that hams in Italy and several other nations are very angry over accusations that their terrestrial operations interfere with satellite communications. They say that like it or not, they are legal and that they can run FM and repeaters where they please.

Packet and internet postings from hams in Italy say that the Italian Telecom Ministry allows them to operate on 435-436 as a primary service and on 432-434 Mhz and 436-438 MHz as secondary. That no mention is made in Italian communication law of separate satellite subbands. As such, the Fmers say that they are free to do as they please.

The Italian Amateur Association has requested that all of its members use and respect the IARU bandplan and the organization has had some success. But non members can and often do operate where they want using any mode that is legal. Because of the way that the rules are written, no action to prevent them from using satellite frequencies will be taken by the government agency.

# UK: NO MORE 934 MHz CB

The United Kingdom will cancel its 934 Mhz Citizens Radio band on December 31st of 1998 and the band will be converted to a commercial digital telephone service. The current 27 Mhz United Kingdom CB service will continue to be available until further notice from the UK Radio Communications Agency.

# **FUJI 3 LAUNCHED**

Ham radio has a new satellite courtesy of the hams of Japan. Carried aloft on a Japanese H-II rocket, the amateur satellite JAS 2 was successfully launched at 01:54 UT on Saturday, August 17 by the Japanese Space Agency. This, from their space center in southern Japan.

Now renamed Fuji 3, several stations in the Americas and especially in the eastern USA reported hearing Fuji's CW telemetry beacon soon after it separated from the launch vehicle. This, over Antarctica during its first orbit. One of those stations was manned by AMSAT-NA's Executive Vice President, Keith Baker, KB1SF located in Xenia, Ohio. Baker says that being one of the very first to hear signals from a brand new Amateur Radio satellite has to be one of the biggest thrills one can have as a ham.

Fuji 3 is similar to OSCAR 20, although it offers some interesting twists. As soon as testing is completed hams will have access to an easy to use packet BBS. Unlike most digital satellites which function as file servers and require specialized ground station software, Fuji 3 provides a BBS that operates much like a terrestrial system. The only software required is a terminal program to talk to your TNC. Connecting to the BBS is as simple as sending a connect request to 8J1JCS.

Hams who own PSK TNCs can connect to Fuji 3 at 1200 baud, but unlike OSCAR 20, this new Japanese bird can handle 9600 baud FM Frequency Shift Keying as well. A digital voice storage unit or Digitalker will be used to transmit announcements, bulletins on the condition of the satellite and so on. It's similar to the unit presently being heard from the Mir space station.

Fuji 3 also features a linear transponder for SSB and CW. At this time there has been no word from the Japan Amateur Radio League concerning an operating schedule for the transponder versus the BBS.

Well, keep your radios on and your ears open as we head into equinox. The DX will soon be rolling in. Jim, WV5S



Contest season is rapidly approaching but there is time to get those antennas up. In the process of laying out the location of the base and guy wires for the second tower. I learned some neat tricks. Here's what I learned.

The Rohn tower book shows the basic lay out but doesn't tell how to actually lay it You want exactly 120 degrees between each of the guys and they show a drawing similar to the one here except that I've added the dashed lines. Since the distance the guys are located from the tower are given for a particular height, distance 'c' will always be known. By adding the lines 'a' and 'b'. I have made two 30, 60, 90 degree triangles. Now the laws of right triangles come into play and you can determine the other distances simply by calculating them. The easy way is to know that for a 30, 60, 90 degree triangle side 'a' will always be 1/2 of side 'c' and side 'b' will always be .866 of side 'c'.

So much for that. Here's how you lay it out. In my case the distance of the guys from the tower were 70 ft. That made distance 'c' 70 ft. Distance 'a' then was half that or 35 ft. and distance 'b' was .866 times 70 ft. or 60.6 ft. (60 ft. 7.5 in.). Where you start depends on how you want the guys oriented on your property. In my case along a fence with one guy in the corner of the property. I placed stake 1 where I wanted the first guy. I continued along the fence 60 ft. 7.5 in. and drove stake 2 there. I continued in a straight line another 60 ft. 7.5 in. and drove stake 3. I returned to stake 2, measured 35 ft. at right angles to the fence and drove



stake 4. To make sure that I traveled at right angles to the fence. I checked the measurement from stakes 1 and 3 to stake 4 to make sure they were 70 ft. They weren't so I had to move the stake a little to make sure that both measurements were 70 ft. while maintaining the 35 ft. distance from stake 2 to 4.

Next I measured out 70 ft. past point 4 and drove stake 5. To position stake 5 accurately, I lined up with stake 4 and stake 2.

When I was at a place where I couldn't see stake 2 because it was shadowed by stake 4. I knew that I was in line and drove the stake at the 70 ft. mark. This will work with any distance 'c'. To get that information you will have to refer to your tower book. It varies with the type and height of the tower that you are installing.

I phone Asmara day before yesterday (August 20th) and received the same answer as nearly a year ago." (from the Ohio/Penn DX Bulletin).

# NEW RF SAFETY STANDARDS

The new government mandated RF safety standards for ham radio operations that were announced last week are causing cries of indignation from many in the Amateur Radio community. Hams are saying that they don't want them and some say that they are readying legal challenges to stop their implementation.

The new rules announced by the FCC take effect on January 1, 1997. They will impact on the way hams running 50 watts or more peak envelope power out, on any band, operate. Also, on the way every radio amateur interfaces with the non ham community. This is because the FCC now will require hams to consider the possibility of health problems related to radio frequency energy exposure from their stations to members of the general public.

In its Report and Order on ET docket 93-82, the Commission adopted Maximum Permissible Exposure limits for electric and magnetic field strength and power density for transmitters operating at frequencies from 300 kHz to 100 GHz. This includes transmitters used in the Amateur radio service. These new MPE limits generally based are on recommendations of the National Council Protection Radiation on and Measurement. In some respects, they are also based on the guidelines issued by the

Institute of Electrical and Electronics Engineers and subsequently adopted by National American Standards the Institute. In formulating the new rules the Commission used the 1992 ANSI and IEEE standards instead of the 1982 ANSI The 1982 standards had standards. formed the basis for the existing rules under which Amateur Radio stations were categorically exempted. And judging by conversations heard on the air, monitored on packet and going on the Internet, the ham radio community wants the old standard put back in place.

While ARRL Executive Vice president Dave Sumner, K1ZZ writes that the FCC expects it will not be difficult for most amateur stations to show that the specified limits will be met, hams are not convinced. Most fear that the enactment of these new RF exposure guidelines will give new legal arguments to states and municipalities to ban not just antennas and towers, but also the operation of radio transmitters as well. Hams also worry that the federal, state and local bureaucracies will each place individual demands on ham stations to prove compliance through costly scientific testing. Testing that some say, no ham could afford.

Also worrying hams is the question of personal liability. Many Internet postings note that there are a lot of lawyers looking to make names for themselves by soliciting cases that hold the possibility of setting legal precedents. Many wonder who will be the first target of one of these career seeking legal minds willing to bankrupt a ham just to put his name in the ranks of legal experts on another innocuous cause celebe.

As we go to air, it is not clear as to exactly what is involved in conducting a routine RF radiation evaluation. Dave Sumner says that the commission has promised to release a revised bulletin titled Evaluation Compliance with FCC Specified Guidelines for Human Exposure to Radio Frequency Radiation. It is hoped that document will spell out the level of involvement and monetary expenditure of RF compliance certification that will be required by hams. In the meantime, the ARRL says that it is studying the 100 plus page docket, to see if the League should seek reconsideration of any aspect of the FCC decision. Even if the League does not file a challenge, from what we are reading on the Internet, it seems likely that more than a few individual hams will.

# FCC VANITY CALL SIGN ADVICE: READ THE DIRECTIONS!

The FCC wants hams to be a lot more careful in the way they fill out their paperwork when applying for vanity call signs. So says Larry Weikert, who is the FCC's point man in Gettysburg for processing vanity call sign applications. Weikert says that many vanity applicants are failing to follow directions when filing the Form 610V vanity call application. He asks that all applicants take the time to carefully read the instructions and follow them explicitly to avoid problems or disappointments. In addition, applicants should always print legibly.

Weikert also says that some applicants are attaching Form 610s to their vanity call sign applications to renew licenses or to file an address change. He says that Form 610 transactions should be filed separately. They should not be included as part of a vanity call sign application.

# HAM RADIO CONCLUDES AIR CRASH SUPPORT

More than 125 hams from the Greater New York City-Long Island vicinity have already contributed more than 2500 volunteer hours to support recovery operations in the wake of the TWA Flight 800 disaster. Although the recovery effort continues, and Amateur Radio remains on call, official involvement by hams concluded the last weekend in July.

Walt Wenzel, KA2RGI, the regional RACES officer for the New York State Emergency Management Office had high praise for the work of the ham radio volunteers. Wenzel also offered some lessons learned from the recovery support effort. He says that hams must learn not to always count on 2 meter repeaters alone to provide coverage of a disaster area. He also says to keep a database of available equipment that can be loaned to operators who turn out to help.

# W2NSD FILES PERSONAL BANKRUPTCY

Financial problems continue for 73 Magazines Wayne Green, W2NSD. On July 3rd, Green filed a voluntary petition for Chapter 7 individual bankruptcy in the United States Bankruptcy Court for the District of New Hampshire. In his petition, Green lists his total assets at just over \$5000 and liabilities exceeding one million dollars.

Greens' declaration of personal bankruptcy comes only a month after his Wayne Green Incorporated filed for business bankruptcy. Not included in either filing is 73 Magazine long associated with Green. Two years ago 73 was sold to his wife Sherry Smith-Green. Sherry Green reportedly has a new staff

already in place so that publication of 73 should remain on schedule for the foreseeable future. Wayne Green, W2NSD, is expected to continue contributing editorially.

FCC to open Gate 2

The FCC has announced that vanity call sign filing Gate 2 will open September 23. Under Gate 2, Amateur Extra class licensees may request a vanity call sign on or after that date. File requests on FCC Form 610V. Legibility is critical. If your application is not legible, you could experience a delay in processing, lose the opportunity to obtain a requested call sign or even obtain a call sign different from what you want.

Under Gate 2, you must hold an unexpired Amateur Extra class operator/primary station license to request a vanity call sign for your primary station. To request a vanity call sign for a club station under 4. Gate 2, you must also hold an unexpired club station license grant listing you as the license trustee. Applicants should refer to the licensee data base to verify that a requested call sign is not already assigned. A call sign is normally assignable two following license expiration, years surrender, revocation, set aside, cancellation, void ab initio, or death of the grantee.

Using Form 610V, provide a list of up to 25 call signs in the order of preference. The first assignable call sign on the list will be assigned to your station. Remember: When requesting a call sign under Gate 2 for your primary or club station, the call sign must have been unassigned for at least two years. As an Amateur Extra class operator, you may request a call sign from any group, A, B, C or D.

Any call sign requested must be one designated for the region of your mailing address, as follows:

One of the contiguous 48 states: Regions 1 to 10.

Alaska: Regions 1 to 11.

American Samoa: Regions 1 to 10, or

Region 13 having numeral 8.

Commonwealth of Northern Mariana Islands: Regions 1 to 10, or Region

13 having numeral 0.

Guam: Regions 1 to 10, or Region 13

having numeral 2.

Hawaii: Regions 1 to 10, or Region 13

having numeral 6 or 7.

Puerto Rico: Regions 1 to 10, or Region

12 having numeral 3 or 4.

Virgin Islands: Regions 1 to 10, or Region 12 having numeral 2.

For explanations of Groups A, B, C and D and the geographic Regions, see Fact Sheet PR5000 Number 206-S, Amateur Station Sequential Call Sign System. For more information, see Fact Sheet PR5000 Number 206-V Amateur Station Vanity Call Sign System.

Advanced, General, Technician Plus, Technician, and Novice class operators are not yet eligible to request by list. Advanced class operators will be eligible at Gate 3. Others will be eligible at Gate

ARRL/VEC electronic filing

Effective immediately, the ARRL/VEC will electronically file with the FCC Forms 610 for ARRL members. The ARRL/VEC can electronically file FCC Form 610 applications for amateur station license renewals, or for address, name or call sign changes. This service is free to current ARRL members.

ARRL members must send a correctly completed, signed and dated original Form 610 to the ARRL/VEC. Members can send the Form 610 by US mail, by courier, or hand delivery to ARRL/VEC, 225 Main St., Newington, CT 06111. Applications received by the ARRL/VEC must include an original signature. Forms 610 cannot be accepted via fax.

Only applications for renewal made on FCC Form 610 may be electronically submitted by VECs. For now, VECs cannot process computer-generated Forms 610R (which are mailed by the FCC directly to upcoming expirees). Those must go directly to the FCC. Also, VECs cannot presently process FCC Forms 610A, 610B, 610R or 610V. FCC Rules stipulate that renewals be submitted to them no earlier than 90 days before the license expiration date. Licenses that have been expired for less than two years may still be reinstated. A Form 610 for renewal must be submitted to a VEC or FCC before the two-year grace period has ended.

Applications for a systematic call sign change must have Box 4E checked, and the applicant must initial the line adjacent to the box. Applications for an address change must include a current mailing address that is within the United States or its possessions or territories (i.e., where mail can be delivered by the US Postal Service).

Applications submitted for a name change must include a copy of a legal document showing the formal name change. The former name must be written on the line next to Box 4C. Typographical errors can be corrected using Form 610.

New RF standards Part 2 (continued from part 1)

The new regulations also will require the addition of five questions on RF environmental safety to the amateur examinations for Novice, Technician, and General-class elements 2, 3(A) and 4(B). Sumner noted that the Commission's Report and Order does not take into account the practical problems associated with such a significant revision to the volunteer-administered amateur examinations, and that more time than the Commission has allowed will be required http://www.fcc.gov/Bureaus/Engineering to do a good job.

The Commission acknowledged the updated guidelines generally are more stringent than the current rules but said that the new rules will protect the public and workers from strong RF emissions. Adoption of new rules by August 6 was required by the Telecommunications Act of 1996.

The FCC encourages the amateur community "to develop and disseminate information in the form of tables, charts and computer analytical tools that relate such variables as operating patterns, emission types, frequencies, power and distance from antennas." The Commission said it intends to provide "straightforward methods for amateur operators to determine potential exposure levels" by year's end.

In comments filed earlier with the FCC. the ARRL strongly opposed adoption of the new requirements. The ARRL said most Amateur Radio users do not possess the requisite equipment, technical skills, and/or financial resources to conduct an environmental analysis. The League has, for several years, recommended a policy of "prudent avoidance" of exposure to electromagnetic radiation as a commonsense approach to potential--but not yet proven-health hazards and against such practices as running high power to indoor antennas or to mobile antennas that might expose the vehicle's occupants. The ARRL also argued that amateur stations, because of their intermittent operation, low duty cycles, and relatively low power levels. rarely exceed the 1992 ANSI/IEEE standard. Finally, the ARRL noted that unlike other radio services, RF safety questions already are included in amateur license examinations. But the FCC expressed concern that Amateur Radio operations "are likely to be located in residential neighborhoods and may expose persons to RF fields in excess of the MPE guidelines."

For now, the League advises hams not to panic and to read up on the subject. You can download the complete Report and Order by Technology/Orders/fcc96326.txt. Other resources are available on the ARRLWeb page at http://www.arrl.org/news/rfsafety/.

General information on RF safety is available in the safety sections of The 1996 ARRL Handbook and in the 15th edition of The ARRL Antenna Book. These materials offer guidelines on how to comply with the ANSI standard referred to in the Report and Order.

New RF standards Part 1

New FCC RF safety standards effective January 1, 1997, could affect the way some hams operate, perhaps especially those using vehicle-mounted antennas. As a result of a Report and Order adopted by the FCC on August 1 (ET Docket No.

93-62, Guidelines for Evaluating the Environmental Effects of Radiofrequency Radiation), Part 97 will require hams running more than 50 W PEP to conduct routine RF radiation evaluations to determine if RF fields are sufficient to cause human exposure to RF radiation levels in excess of those specified. during made "Measurements Commission/EPA study of several typical amateur stations in 1990 indicated that there may be some situations where excessive exposures could occur," the FCC said in ending the blanket exemption for Amateur Radio. Amateur operation at power levels of 50 W PEP or less is "categorically excluded" from the exposure requirement in most cases. Where routine evaluation indicates that the RF radiation could be in excess of the limits. "the licensee must take action to prevent such an occurrence," the Report and Order stated. The FCC said this could operating patterns, altering mean relocating the antenna, revising the station's technical parameters--such as frequency, power or emission type--or "combinations of these and other remedies."

"Exactly what is involved in conducting a 'routine RF radiation evaluation' is not yet Executive observed ARRL clear." Secretary David Sumner, K1ZZ, adding that the FCC has promised to release a revised OST/OET Bulletin Number 65, "Evaluation Compliance with FCC-Specified Guidelines for Human Exposure to Radiofrequency Radiation." Sumner noted that the FCC expects it will not be difficult for most amateur stations to show that the specified limits will be met.

In the Report and Order, the Commission adopted Maximum Permissible Exposure (MPE) limits for electric and magnetic field strength and power density for transmitters operating at frequencies from 300 kHz to 100 GHz. These MPE limits are generally based on recommendations of the National Council on Radiation Protection and Measurement (NCRP) and, in many respects, are also generally based on the guidelines issued by the Institute of Electrical and Electronics Engineers Inc. (IEEE) and subsequently adopted by the American National Standards Institute (ANSI) as an ANSI standard (ANSI/IEEE C95.1-1992). The Commission used the 1992 ANSI/IEEE standards instead of the 1982 ANSI standards that had formed the basis for the existing rules under which Amateur Radio stations were categorically exempted.

Sumner said that for high-power mobile operation and for operation with indoor antennas, particularly in apartment buildings and other situations where there is "uncontrolled exposure" to neighbors and the general public, "amateurs may well have to make changes in how they operate." He said the ARRL Lab staff and the RF Safety Committee will be evaluating the new requirements.




