Dear Members of CORA;



Lazy Wife Cake

1 1/2 c. pastry flour 3 Tablespoon cocoa 1 teaspoon soda pinch of salt 1 c. sugar powdered sugar

Combine the above ingredients in sifter and sift into mixing bowl. Mix with fork (no spoon) and make 3 holes in dry ingredients. In one hole put 1 teaspoon vanilla; in another hole 7 Tablespoons cooking oil and in third hole 1 Tablespoon vinegar. Pour 1 cup of COLD water slowly over mixture and mix thoroughly with fork. Bake at 350 degrees for 25 TO 30 minutes. Sprinkle top with powdered sugar when partly cooled.

It did not say what size of pan to use but a medium size pan is what I use. Also I treat my pan with PAM spray before pouring the cake mixture into the pan. Amish Recipes are not always clear and sometimes miss steps. Anyway, this one is made without eggs or milk. Enjoy.

Emergency: W5KCB discussed how the auction of excess club equipment would be handled at the August meeting. Priority would go to members and that there would be an established minimal bid.

Education: KC5IZN was asked to chair the Education Committee. He reported that he would like to see the amateurs get into local schools and make contacts school to school contacts etc. He stressed the need to have on going classes to meet the needs of the local community interest in becoming licensed amateur radio operators.

Membership: No Report

Information and Bulletin: KC5IZN recapped events surrounding Field Day.

New Business: KC5CYY asked about the possibility of a Club QSL card. He stated that there are only a few left and that it would be good to have some made before we need them. He was asked to look into a redesign of the club QSL card.

KC5CYY asked about the possibility of looking into the club purchasing individual callsign badges. The idea was tabled for future discussion.

The meeting was called to order by the President at 7:30 p.m.. Introductions were made. There was 75 members present and two guests. John Baker and Chad Gleaves, KC5OEM.

KC5IZN Introduced the program speaker Claude Machette, KD5RQ. Claude presented an inspiring educational program on Lightning Safety. Complete with a test!

The next item on the agenda went to W5KCB. He explained the bidding process to allow the club to dispose of excess and obsolete equipment owned by the club. The President called for a 5 minute break to allow members to examine the equipment available for bid.

Mark Ewell, KC5IZN and I offered to provide communications support at one of the rest stops. Mark a long time former resident of Wichita Falls TX and member of the WARS club suggested the idea to me several months ago. It sounded like fun. Leaving Lawton about 6:30 p.m. the evening before we arrived at Mark's mom's house in Wichita Falls. There is a viscous rumor that I like to eat and dinner was ready. 

There must have been nearly 45 people setting

up other stations. These stations included medical, refreshments, water, sport drinks, and believe it or not the cast of Gilligan's Island! Complete with the theme song.

It was time for us to set up our station in support of the race. KC5EOM took care of the initial communications. Mark and I went about the task of setting up the generator, tables, shelters and additional radios to monitor the other support frequencies. The station would not have been complete without a TV and yes, we had that too! After all, we had to hear and "see" the start and yes the finish of the race.

The medical folks seemed to being doing the most amount of work, second only to the port-a-pot that is. Anyway, with a host of scraps and other asphalt/bicycle injuries they proved to be a very necessary asset located at this stop. Injured riders and bicycles collected at this rest stop, waiting on the SAG wagon.





This race was well supported with amateurs and well supported with cell phones. Cell phones were utilized when ever there was not a ham available to travel with one of the support medical vehicles. This is one of those times where cell phones worked and worked well! In an emergency cell phones will probably be one of the first things that will NOT work. Amateurs know this and need to make sure that a false sense of security does not develop.

Mark and I both went away from rest stop 2 knowing that we performed a necessary communications function in support of the overall public safety of this event. During one of the quieter moments I had a chance to provide Fernand a copy of the Collector and Emitter. Fernand is the Secretary/Treasurer for WARS. He was

thoroughly impressed with the quality of the collective works of all the clubs. Given his response, he seemed interested in considering the C&E as a possible alternative to their own Newsletter.

We had a great time and met over 20 amateurs that were taking the day off from HAMMING (without pay of course) and were out enjoying the bike race but took the time to say hello and thanks. The lesson to be learned here is that it is OK to help out at other functions that you want to support but that your club may not be supporting. We were able to look at the operation of another organization and learn that there are some things that all amateur groups do and do well, promote our hobby as a vital national resource.

The W5KS Lawton-Ft. Sill Amateur Radio Club is making life better in SW Oklahoma and the world!



FCC issues Gate 3 call signs.

Get ready to remember another batch of new call signs. Six weeks to the day after the opening of Gate 3, the FCC began processing vanity call sign applications. FCC personnel in Gettysburg, Pennsylvania, had spent much of the intervening time clearing out a backlog of vanity applications filed prior to the Gate 3 opening and matching up payments with electronic applications. On Wednesday, September 17, the FCC issued some 600 vanity call signs to those who had filed applications on August 6, the opening day.

Applicants can check for new call signs at http://www.arrl.org/fcc/fccld.html or by using one of the other popular call sign databases.

Judging from the call signs turning up on the FCC database, some Advanced class hams took advantage of Gate 3 to obtain Group C (1x3) call signs where the suffix comprised either a first name (we spotted a Joe, a Don, a Ken, a Bob and a Gay, for example) or a set of initials. Perhaps apropos of his QTH, Gene Uliasz of Gun Barrel City, Texas, used Gate 3 to turn KC4WA into K5TNT. Formerly KF6CG, Georgia A. Lawrence of Manhattan Beach, California, obtained K6GAL.

Other applicants obtained new Group B call signs, sometimes trading one 2x2 in for another. For example, Karl Mortensen of Wakefield, Rhode Island, swapped KE1FK for KA1RL. Still others went for the snappy suffix. Charles Pharis of Kagel Cyn, California, turned in KK6NE Michael Amaral of for KA6USA. Walpole, Massachusetts, gave up W1IDP to obtain WA1AW. Along the same lines, Esposito of Germantown, Michael swapped WA2VXV for Tennessee, WA2AW. Yvonne Lane of Kingwood, Texas, gave up KF5MY for W5XYL.

A few, like ARRL West Gulf Director Jim Haynie, just shortened the prefix. Haynie went from WB5JBP to W5JBP. Others went for one appropriate for their QTH. Teriann Miner of Palmer, Alaska, turned in her lower-48 call sign, KG0OY, for KL7AT.

The Iowa DX and Contest Club got WI0WA.

In all, it appears that the FCC received more than 1000 vanity call sign applications on August 6. Because earlier gates remain open, it's impossible to get an accurate count of applications filed solely under Gate 3, however. The FCC still has not indicated when it plans to open Gate 4, which will make the vanity call sign program available to General, Tech Plus, Technician and Novice licensees.

LARU Region 3 conference concludes in Beijing

Representatives of Amateur Radio organizations in 20 Asia-Pacific countries have spent the past week reviewing proposals and papers submitted by member societies at the 10th Regional Conference of IARU Region 3 in Beijing, the People's Republic of China. The Chinese Radio Sports Association (CRSA) hosted the week-long conference, which just wrapped up. Representatives of the ARRL also were on hand for the event, September 8-12.

Only a fortunate few in North America were able to hear--or even work--special event station BT1IARU, the on-air emblem of the Region 3 gathering. Although conditions were not favorable to this part of the world, the station made many QSOs elsewhere. Things also went well at the conference itself.

The conference's three working groups developed recommendations for consideration by the full conference. Recommendations adopted by the conference dealt with subjects as diverse as preparations for future ITU World Radiocommunication Conferences, strategic planning for the regional organization, electromagnetic

compatibility issues, the IARU monitoring system, beacons, Amateur Radio direction finding, and many others.

Among conference highlights was the participation of representatives of the Vietnam Amateur Radio Club, which hopes to join the IARU.

David Rankin, 9V1RH, retired as a director after 24 years of service as Regional Secretary and Director, half of that time as Chairman of Directors. The other incumbent directors, HL1IFM, JJ10EY, ZL2AMJ, and 9M2SS were re-Former Director David A. elected. Wardlaw, VK3ADW, was returned to office. Keigo Komuro, JA1KAB, was reelected as Regional Secretary. Fred ZL2AMJ, continues Johnson, Chairman of Directors.

The more than 100 conference attendees complimented the CRSA for the arrangements, which included excellent logistical support of the conference plus a visit to the Great Wall and the Summer Palace in Beijing.

Representing the ARRL at the Beijing conference were ARRL President Rod Stafford, KB6ZV, assisted by First Vice President Steve Mendelsohn, W2ML, and staff members David Sumner, K1ZZ, Paul Rinaldo, W4RI, and Naoki Akiyama, FCC Form 159 can be obtained by writing control stations. All vanity applications to require Form 159

The ARRL has learned that when the vanity application fee jumps to \$50 on Monday, September 15, the FCC also will start requiring everyone filing a paper Form 610V Amateur Station Vanity Call Sign Request to include FCC Form 159, FCC Remittance Advice, with their application--no matter the method of payment. Applications received on or after September 15 and lacking a Form

159 will not be processed and will be returned to the applicant.

Previously, the FCC only required an Form 159 with a hard-copy Form 610V if the applicant was paying with a credit card or money order--or for a single remittance to cover multiple applications.

The change came on very short notice, and the FCC has yet to issue a formal public notice to address it. But the FCC appears ready to stand firm on the requirement starting September 15. A spokesperson at the FCC in Gettysburg said that on or after September 15, Mellon Bank--the FCC's fiscal agent--will not cash or deposit any fees which are not Form by accompanied a 159. Applications received at Mellon Bank that lack a Form 159 will be forwarded to Gettysburg for handling (the fee will not be deposited), and Gettysburg will return the entire application and the fee to the applicant with a blank Form 159 and instructions to refile.

159, When completing Form all applicants must include a taxpayer ID number (your Social Security number) in Item 1 (FCC Account Number). In Items 14A and 14 B, Payment Type Code, applicants should write "WAVR."

The FCC still has given no indication of when it will begin processing Gate 3 vanity call sign applications. It's estimated that more than 1000 applicants

filed on the opening day, August 6. The FCC also has not said when it plans to open vanity Gate 4.

Hurricane Watch Net activated as Erika eyes Caribbean

The Hurricane Watch Net has been activated and is currently in standby mode on 14.325 MHz as category one hurricane Erika moves toward the Lesser Antilles. A hurricane warning is in effect from Antigua and Montserrat northwestward through St Martin. With their sections under a hurricane watch, ARRL Virgin Islands Section Manager John Ellis, NP2B, and Puerto Rico Section Manager Guillermo Schwarz, KP3S, report that preparations for possible ARES activity are under way.

At 2 PM AST/EDT, 1800 UTC, Erika's center was located near 16.9 north, 58.5 west, about 215 miles east of Antigua. On its present westward course, the storm, with sustained 75-mph winds, will be centered near the northeastern leeward islands on Saturday morning.

Amateurs are advised to monitor storm emergency net frequencies. Do not transmit unless directed to do so by net advisories are available from many sources including NOAA weather radio, the National Hurricane Center home page at www.nhc.noaa.gov, and the Hurricane Watch Net home page www.weathernode.com/hwn.

under earlier vanity gates. The FCC reports it received 1613 vanity call sign applications between August 6 and August 20. That total could include applications filed under earlier vanity gates, however.

An FCC spokesperson said this week that personnel are very carefully matching up fees paid with applications filed to ensure that any call sign request that can be granted, will be granted. In particular, the FCC wants to be sure that no fees for electronic filers go astray. Most of those who are seeking new call signs under Gate 3 filed electronically, but payments still had to be sent by mail.

The fee-handling procedure initiated with Gate 3 is a change from how fees were handled under earlier vanity gates. Under the current procedure, the FCC requires fees accompanying electronically filed applications to be paid (and received by the FCC bank contractor, Mellon Bank) within 10 days of filing. The FCC will not process an application before the fee is received. The fee for a vanity call sign application increases from 30 dollar(s) to 50 dollar(s) on September 15, 1997.

The FCC still has not given any indication when it plans to open Gate 4.

Massachusetts Attorney General: No to Restrictive Tower Law

Closer to home, the office of the Attorney General of the Commonwealth of Massachusetts has rejected restrictive zoning by-law enacted by the Town of Easton on April 14th. The by-law, known as Article 43 had placed tight restrictions on towers, antennas, and satellite dishes.

Rob Leiden, KR2L reports via the satellite radio program "This Week in Amateur Radio" that back in the early '90's Massachusetts hams had worked to enact a statewide version of the FCC's PRB-1 federal preemption act. The state measure was signed into law in 1995 by former Governor William Weld. This was the kind of test case it was waiting for.


In Massachusetts, the Attorney General has to approve all zoning by-law amendments. So a ham radio action group sent a copy of the states PRB-1 clone to the Attorney General's Office and asked that it be compared to the Easton covenant. It took a few months, but now the state's top lawyer has sided with amateur radio.

In a letter to the Easton Town Clerk the Attorney General said: "These restrictions, as applied to amateur radio antennas, violate state law that says no zoning ordinance or by-law shall prohibit the construction or use of an antenna structure by a federally licensed amateur radio operator.

Zoning by-laws may reasonably regulate the location and height of such antenna structures for the purposes of health, safety, or aesthetic; provided, however, that such by-laws reasonably allow for sufficient height of such antenna structures so as to effectively accommodate amateur radio communications by federally licensed amateur radio operators."; The Attorney General concluded that because this critical portion of article 43 is inconsistent with state law that he is required to disapprove the article as written.

Needless to say that Massachusetts hams are happy with the outcome of this challenge to Easton Article 43. Had it become state law it could cost from \$30,000 to \$50,000 for any ham to fight it in court.

THE CONTEST CONTINUUM

Building a Contest Station continued

(This month Coy continues to relate his tower raising experiences. In this installment Coy talks about tensioning guys, Phillystran guy material and running coax to the tower. Enjoy! Ed.)

I spent as long tensioning the guys and getting the tower vertical as I did in stacking the steel. If I had owned or borrowed the proper equipment, this would have been much easier. However, since I don't own a transit or a gauge to set the tension. The first thing I did was to dig out my old plumb bob. It worked real well until the wind started blowing a little too hard and I couldn't keep it from swinging. Next I checked the corners of the house and the storage building with a level to make sure they were vertical. I used them to eye the tower from different angles to make sure it was vertical.

I put in a lot of miles walking from the three guy sets to the corners of the house and building. I would tighten/loosen guys

while checking for vertical. I tensioned the guys using sag. I don't recommend it but it was what I had. I've put up enough towers that I can read them fairly close.

I made the top set of guys from Phillystran, except for about 15 ft at the bottom. The bottom 15 ft is EHS strand. It won't melt if I have a grass fire (something I have to watch for out here in this pasture land and wheat fields) and it won't cut with a knife. I learned a few things about Phillystran. I used the 4 clamp method to secure it on each end. I learned real quick that it is easy to over tighten the clamps. It holds much better if you don't tighten them as tight as you can get them. It seemed to have the best grip when I tightened the nuts until the pressure applied caused the cable to bend at the clamp while holding it in my hand. I don't have full confidence in the Philistine yet because of the problems that some have had with it. But after the storm blew limbs out of my trees the other night, I'm a little more confident in it now.

To get the coax to the tower, I buried 2 inch PVC. I bought a narrow drain shovel to do the trenching with. It worked real well and dug just the right width trench. I put the PVC down 18 to 24 inches with an up turned elbow at each end. I placed a 3/16 Dacron rope through all the PVC sections before I glued them together. That way my pull rope was inside the pipe when it was finished. It was about a 120 ft run from the back of the shack to the second tower. I pulled the rotor control cable and two runs of RG-213 through the pipe with ease. After I pulled the cables through I threaded the cables through a PVC "U" section on each end to keep rain from filling the pipe. (So far it has stayed dry) I decided on RG-213 after talking with the folks at Cable Experts. The losses are not significant at HF frequencies and it will handle the power that I plan on running to the antennas without any problem.

Placing the 40 meter beam on the tower posed a significant challenge. This is not a large antenna but it isn't small by any means. It's an M2 (M-Squared) 40M2L that weighs 55 lbs with 46 ft elements.

Next time, we'll look at how I got it atop the tower without removing the guy wires. I'll also address some rotor problems, 20 meter beam thoughts and considerations for 80 meter antennas.

Don't ask QSL managers to commit postal fraud!

(The following was sent out by OKDXA member Frank Smith, AHOW on the DX Reflector. It seems there are some DXers who are trying to "reuse" their stamps by placing them out of the machine cancel range! This puts the sender, the QSL manager or provider, liable for postal fraud. Read on ...)

DX Friends -

We just received another large bundle of QSL card requests from our Midway operation of last year. Most of these are going out today. If you haven't received yours, I'll be glad to research it, via return e-mail. There are some that are not being answered; read on:

As with past operations where I've been involved, it seems like there's always a handful of QSLers, and it's usually the same people time in and time out, who attempt to prove that "Hams are Cheap". It would seem that for American hams, a 32-cent stamp should be affordable, especially when guys are out there purchasing big towers, arrays, big rigs and Alpha's, etc. It's these same guys who think they are being clever when they place the return 32-cent stamp just about anywhere on the return SASE except where it's supposed to be ... possibly so that the US postal service's cancellation stamping equipment will miss their 32cent stamp???? In some cases, it's the foreign hams who do the same thing. In some of these cases, however, if we judge that an honest mistake is involved, we will hand cancel the stamps send the card out. Again, there are repeat offenders, one in particular being a guy who is a known contester that lives in Southbury, CT. He seems to like putting the stamp just below the upper right hand corner. There is no Fortunately, these offenders are in the excuse for American hams who do this.

After all, we're taught in elementary schools here that the stamps must be placed in the upper right-hand corner. Pretty simple!

We're even seeing several stamps that have been used before! The steam and reglue job in most cases is of shabby work. Some don't even bother to remove the paper it was glued to before, leaving layers of paper between the stamps and the envelope!

I have taken several of these envelopes to the US Postmaster at a major postal center in the Phoenix area. Guess what? According to the PM, this is called "postal fraud" and it happens quite often. The PM explained to me, however, that even though the offender is the end user, the

legal onus is on the sender, or myself or my QSL manager who happens to be mailing the envelope in question. Therefore, the PM explained, we're being asked to commit postal fraud every time this happens.

So the policy for the various cards that I personally handle as well as those our QSL manager handles is that such cards will not be honored. As many of you know, KH7U and I are heading up a team DXpedition to Kure in the near future, and the QSL policy will be the same. Further, repeat offenders are simply being removed from the logs - in fact, I have discussed this with the ARRL, and they agree that we have every right to do this for this reason.

I have privately spoken with other QSL managers, and collectively, we've agreed that as a minimum, such cards will not be honored.

Let's keep DXing a matter of honesty and integrity all the way. There's a whole category of sleeze in this hobby. So, please, guys, let's keep it all above board. Nothing is worth compromising your ethics and integrity. Is there any pride or sense of accomplishment if this is the way you get your operating awards?

AMSAT P3D Launch Delay Official

AMSAT's Phase 3 D ham radio satellite will definitely not be launched aboard the Ariane 502 booster later this month and AMSAT has begun negotiations for a new launch opportunity.

Ron Broadbent, G3AAJ, of AMSAT UK tells the GB2RS News Service that Phase 3D will not be on Ariane 502 that's due for launch on the 30th of September. He also tells GB2RS that AMSAT's Phase 3D launch contract with the European Space Agency has been canceled by mutual consent.

Two weeks ago AMSAT here in the USA made it official that the Phase 3D payload would not be ready for the late September launch. This is because ESA provided last minute new data that forced AMSAT to structurally modify the Phase 3D spaceframe to bring it up to new mechanical standards. But, making the changes put Phase 3D out of sync with the Ariane 502 launch schedule. It has also added \$25,000 to the satellites prelaunch cost.

But in making the announcement Broadbent also has good news. He says that a launch contract for Phase 3D is now being renegotiated with ESA.

At the same time, AMSAT is also talking with various other unnamed launch agencies. Broadbent says that at the moment options are very fluid but there is a good possibility of a launch in as little as five or six months time.

FCC Wins In Court Against 2 Unlicensed Broadcasters

The FCC has won two major victories in legal actions it filed against two unlicensed radio operators.

On September 5th, the United States District Court for the District of Minnesota granted the Government's motion for judgment on the pleadings in a pirate radio case. The Court support the Government's actions in seizing equipment which had been used for operating an unlicensed radio station in Minneapolis, Minnesota.

And The U.S. District Court for the Middle District of Florida, Tampa Division, has granted the Government's motion for summary judgment. This, affirming the seizure of radio equipment in a pirate radio case.

Both cases are precedent setting in that they affirm laws already on the books. Laws that give the government the unilateral right to confiscate any unlicensed transmitter if its operated in violation of FCC rules.



OK to Jam - Another Country

Meantime, the government is saying that its OK to jam radio signals, as long as IT is the one doing the jamming and its not happening here at home. In what news reports say is "a sign of escalating tension";

the Pentagon ordered three electronic warfare aircraft to Bosnia on Thursday September 11th. This, to try to silence anti-NATO broadcasts by rebel Serbs.

The aircraft being used as airborne jamming platforms are Air Force EC 130's. They are propeller driven and carry deployable antennas as well as equipment to broadcast on television, shortwave and medium wave radio and military frequencies. The planes were last used in Somalia and Haiti to relay announcements to local populations and to interfere with local radio broadcasts.

The move to deploy these aerial jammers comes after Bosnian Serbs reneged on an agreement to curb the anti-NATO rhetoric that has fueled confrontations between U.S. soldiers and rock-throwing Serbian mobs.

Susan Goldwater asked that the American public trust that the family is taking very good care of Barry, adding: "He is very much at home, preferring to be here and doing just what he wants to do.": A statement read by his son, Barry Goldwater Jr. backed her, saying family members all are working together to make his dad's remaining years as happy and comfortable as possible.

It is because of Barry Goldwater that congress was convinced to enact the enabling legislation that made possible the all volunteer testing system and Amateur Auxiliary to the FCC. Barry also shared his amateur radio hobby numerous times with millions of would-be hams through his appearances in numerous ARRL and AMSAT sponsored films and videos.

Now in his declining years Barry says he wants to step out of the spotlight and let others take his place. We know that you join us in saying: "Mr. Senator -- well done"

HAM HIGHLIGHTS

Hello, again. This month, we would like to highlight one of our Club's invaluable assets, Jim Richardson, N5OHL. Jim has been an active EARS member for many years. He is a Personnel Systems Manager at Tinker AFB. He and his wife, Linda, N5OJP have three children, Paul, KB5KPL, Jennifer and Emily. But, wait a minute. I'll just let him tell you his story.

"How it all got started: Back in 1988, my wife Linda and I worked as volunteers for a parade in Warr Acres. We were very impressed with the ham radio operators who staged and coordinated the parade using these neat little radios they called "handi-talkies". Phil, N5HIP asked us if we wanted to become amateur radio operators. He said that the Edmond Amateur Radio Society was going to teach a class in the Fall. We went to the class in Edmond, studied hard, and passed all the tests. That's how it all got started.

Linda and I received our Novice licenses in early 1989 (back then, it was 6 to 8 weeks before you got a ticket in the mail). My call was KB5INN and Linda was KB5INM. Yuck! Can you imagine how confusing to use these calls. Was that an "n" or an "m", over?? When we passed our Technician test, we naturally asked for a new call. I received N5OHL. Linda had her paper work come back for a signature, so we did not get sequential calls. She is now N5OJP. This is better anyway because sequential calls are at best confusing.

Linda was only interested in local VHF radio, so she has become a member of the "Technicians Forever Club". I was amazed with HF radio and how far you could talk with only some wire up in a tree. I purchased a used Kenwood TS-520 from a friend, put up a 40 meter dipole and called "CQ" for the first time in August of 1989. My first CW contact was with a ham in Missouri. I must have been doing no more than 5 wpm and remember asking for repeats. The poor guy was nice enough to slow down for me. I later found out that he was an Extra class operator.

At that time I did not have a computer, so no Super Morse! I found Code tapes boring. Everyone was telling me the best way to upgrade was to get on the air and make contacts. So I did try to make at least one CW contact per day. It was really lots of fun working 40 meter CW. You never knew where the signals would go. One of my first contacts was with a guy who had a call sign that started with "CE". I was so "green" that I didn't even think I had his call sign right. Chile was my first DX contact.

Two months later, after working over 25 states and even a few DX countries with my straight key, I passed the General test. Needless to say, I was very pleased. The next month I passed the Advanced test. A year later I made it all the way to Extra class. Little by little, I made more and more HF contacts, meeting all sorts of nice folks on the radio. I even entered a contest or two. My operating skills improved, along with new antennas I put up. I read about everything you could find

on antennas. It doesn't take a rocket scientist to figure out that a good antenna is more important than fancy bells and whistles.

In 1990, I had enough QSL cards to qualify for WAS. I also liked to work DX, especially on 10 meters. It took a lot more work to get DX cards, but in 1991, I received the DXCC award.

Currently, my HF station consists of a Kenwood TS-140S transceiver with an Ameritron 811H amplifier. For 10-15-20 meters, I use a Cushcraft A3 beam at 35 feet. On 40 and 80 meters, I have dipoles. And last year, I managed to put up an inverted "L" for 160 meters. I also have a dual-band Icom 3200A rig for VHF/UHF. For packet, I run a classic Icom 22A crystal-controlled 10-watt radio. It may surprise you to know that I do not own a handi-talkie! Even though this is what sparked my interest in amateur radio, I now know that they are not for me. I like something with a real antenna, not an aircooled dummy load.

My EARS club activities have included: Secretary 1990, Vice-President 1991, and currently Board member. I have been Field Day Committee chairman three times, and am active with the EARS club station. (Jim is also our Net Control Manager for the Monday Night Information Net - Ed.)

Awards: WAS, DXCC, and very close to getting 5-Band WAS. I currently have 162 countries confirmed. (That second 100 is much harder than the first!) Now I am the ARRL WAS manager for this area. I am also Awards Manager for the 3905 Century Club for 5th Area

My ham radio highlight was in 1993. My father, Fred (KB5MRU) and I went to Hawaii during the ARRL 10-meter contest. We stayed on the island of Maui at a bed and breakfast run by Terry KH6SQ, complete with HF station. With about 400 contacts in the mixed CW and Phone category, I took first place in the Pacific section.

My most memorable contact happened one afternoon when I turned on the rig after getting off work. It was on 15 meters and at first the band sounded dead. I turned the dial and listened - nothing. But wait! Was that a YL voice? I listened closely. I could hear the YL, but not the other station. She gave her call as VR6YL. Well, I know who that is! I waited for the right moment and gave my call only once. She said for the 5th area call to stand by. I waited for about 10 minutes while she chewed rags with this other station, which I could not even hear. Then she finished and said, "Is the 5th area call still there?" It was nice to talk with a DX station and get more than just a signal report. This was, of course, Betty Christian on Pitcairn Island. She is a direct descendent of Fletcher Christian who, along with several others, took over the ship "Bounty" way back over 200 years ago. Betty and I talked for about 20 minutes. There was no pile-up or QRM. Betty is a very nice operator. I did exchange QSL cards with her. It is one of my favorites."

Well, folks, there is a peek into the life and times of N5OHL. Jim has had an active ham "career" and is still going strong. For the past few weeks, our Club Station has been without antennas, due to the work the City is doing on the roof. But that never stops a die-hard, does it?! As I climb the stairs to the second floor Club Station, what is this I see inside the hallowed hallway?! A 20 meter dipole clipped to the framing of the dropped ceiling; and down the hall, the familiar sounds of a QSO in progress!!!!
