

# Illegal Operators Beware ! You Will Be Caught !

For over one year repeater listeners in the greater New Orleans area have experienced deliberate and malicious interference much the same as the Dallas/Ft. Worth area have. Unidentified transmissions in New Orleans consisted of obscenities and the sound of a laughing box. While hiding behind a cloak of "bureaucratic indifference" area hams used DF equipment and documented the case before presenting it to the local office of the FCC. With the assistance of Bob Bradley, K5EDV, of the New Orleans FCC office, the offenders were identified and an airtight case was prepared against them, while area hams believed that nothing was being done to alleviate the matter.

The culprits were driving at a high rate of speed while transmitting in an effort to avoid location by conventional DF techniques, but the FCC nabbed two hams, technically competent, who thought that they were able to use their skills to avoid detection.

On November 2, 1977 in the U.S. District Court in New Orleans, La., K5NY, John R. Souvestre and WB5AWN, Keith M. Schexnayder were released on \$2,000 personal appearance bonds after pleading guilty to three counts. The U.S. Attorney dropped five others.

This same thing is happening in other locations around the country. Take heed... The message is clear. Deliberate interference will not be tolerated and you will be caught. The time is now to clean up your act if you are one of the offenders.

We should all remember these points if we are suddenly faced with an unauthorized operator on the air.....

DO NOT acknowledge that they are operating illegally. Try to keep them on the air so that a SWAT team can monitor their transmissions. If you are not directly involved with the QSO go to an alternate frequency and notify a member of the SWAT team and tape record the QSO, if you have the means, so that it can be reviewed later. People who interfere get their jollies by having an audience. Never recognise them. They cannot get as much if they are not recognized. A statement to them that they are operating illegally does no good. This is what they want to hear. Instead, engage them in a good QSO and let the authorities have a chance to DF them. They will be caught and eliminated. In the process a stolen rig may be discovered.

Thanks for the letter Gordon, we AGREE......


To use this number too soon will result in the Fire Department having to transfer your


CRW Coordinator Bob Coker's phone number will also be changed, but it is not known at this time what it will be. You will be advised in next month's edition of "The Mike"





How many of you have lost interest in ham radio? How many of you are new hams who think you must have I,000 watts and a multi-thousand dollar station in order to enjoy your new hobby? How many of you are tired of not having a challenge in working anyone you can hear? I did not fall into any of these catagories, but I had the mistaken idea that one must have the best equipment to enjoy my hobby.

One day while frantically trying to answer a CQ from a Russian station, I forgot to advance the carrier control on my Ft IOI E. After what I considered to be a wasted call, I was just moving the control up to give me IOO watts when I was totally amazed to hear the Russian answer with my call ! I received a 579 report, to my utter amazement. I later checked my power output and discovered that I was delivering a whopping 2 watts to the antenna! What followed was a revelation that every QRPer goes through. If I could work that station with 2 watts, how many more could be worked? In a mere 3 months I have worked 49 states, (Alaska being the last one needed) 27 countries, and only lack Australia for Worked All Continents. I have discovered the thrill of working a rare DX station amongst immense pile-ups. I have found that most serious QRP operators are among the best operators in the world. I would rather try to work WWV with a police whistle than to compete against most of them.

Don't be discouraged by the last few statements though. QRF operators are not born, they learn because sometimes it's the only way you may be heard! It's much easier than you think to be a really good operator.

Let's look at rigs and see what's really needed. If you like to build, QRP is just the thing for you. There are lots of good rigs that can be built for very little money. If at all possible build your rig with a VFO, instead of a crystal controlled rig. As an alternative, use a variable crystal oscillator to give you a few khz to move around in. If you go CW only your choice of circuits is almost unlimited. A class C amplifier will work just fine, but it's a good idea to keep the signal as clean as possible ie, no chirps, clicks etc. There have been several good ideas in magazines over the last few years.

If building is not your bag, there are several very good rigs on the market. The best known of these is the Ten-Tec Argonaut model 509. This excellent little transciver offers features found in much more expensive equipment. It also has SSB, which is something that is difficult to build for a reasonable amount of money. Moving on, there is the Heathkit HW-8. While technically a kit, anyone can assemble one and the finished product is probably better than most of us can brew up. The modifications for the HW-8 are endless, your imagination can be your guide. Next month we'll discuss antennas and maybe a few operating tips.



#### REPEATER INFORMATION AND OPERATING PROCEDURE

The WR5ABY two-meter repeater uses a receive frequency of 146.28 mc, and a transmit frequency of 146.88 mc. The Trustee is Jim Sanders, WB5GBR. The repeater is an "open" repeater, carrier-squelch access, and is located at One Energy Square, adjacent to North Central Expressway, in near-North Dallas. The repeater features an "open" outward telephone interconnect facility, which is available to all users. However, before attempting to use the repeater or its' telephone interconnect facility, PLEASE READ THIS ENTIRE SECTION CAREFULLY.

PRIORITY OF COMMUNICATIONS

One Emergency Traffic (As defined by FCC R&R's). RACES Nets. Urgent Traffic.

Two Technical QSO's concerning general Amateur Radio operation.

traffic has been concluded.

Three General (Shooting-the-bull) QSO's.
Four Telephone Interconnect - To be accessed only after all other

OPERATING PROCEDURE

TO ACCESS THE DALLAS POLICE DEPARTMENT - Call the repeater as you would any other Amateur Station, then without unkeying your transmitter, press the numeral 3 on a telephone-type tone-encoding pad five times. Unkey your transmitter. Note that your call to the repeater must last at least three seconds before you start sending tones. You will hear a dial-tone briefly, and the repeater equipment will begin automatically dialing the police department. When the police operator comes on the line, say "This is CRM 6..." then make your report. If the operator asks for a call-back number, tell her that CRV 6 does not have a call-back number. The repeater has a time-out timer which will turn off the repeater and disconnect the line. This timer is set for approximately two minutes, 45 seconds. If your call will take longer, press the numeral 1 on your tone-pad before this time elapses. This will reset the time-out timer. This proceedure may be repeated as many times as necessary to finish your call. (Note: This feature applies to the police access line ONLY.) Before calling the police, have all the Information (location, address, direction, nature of report, description, etc.) clearly in mind. Speak to the operator slowly and distinctly. When your conversation is terminated, give your call and clear with the repeater, making this transmission last at least three seconds; then without unkeying your transmitter, press the numeral 3 one time. The repeater will then disconnect and return to the normal mode.

TO ACCESS THE TONE-TEST FEATURE - Call the repeater as you would any other Amateur Station, making this transmission last at least three seconds. Without unkeying your transmitter, press the numeral 3 on your tone-pad three times. The repeater will begin transmitting a steady tone, indicating that your tone-pad probably works. To disconnect the tone, clear with the repeater, transmitting for at least three seconds, and then press the numeral 3 one time. TO ACCESS THE TELEPHONE-INTERCONNECT FEATURE - Call the repeater as you would any other Amateur Station, making this transmission last at, least three seconds; then without unkeying your transmitter,

press the \* on your tone-pad one time. Unkey your transmitter, and

listen for a dial-tone, then key your number. Limit the length of your call to less than two minutes, forty-five seconds. Clear with the repeater, making the transmission last at least three seconds, then press the # on your tone-pad one time. The repeater will then disconnect and ID. Use caution, common-sense, and consideration to the other repeater users when making a telephone call --- don't make absurd calls. DO NOT BREAK ANY QSO TO MAKE A TELEPHONE CALL UNLESS IT IS OF AN EMERGENCY NATURE. This is considered quite rude on this repeater. Make no commercial calls.

Monitor the repeater before you use it. Don't enter a QSO unless you

can add something to the subject at hand.

Always enter a QSO giving your call <u>first</u> --- don't say "Break".
 "Break, Break" or "Break, Break, Break" may only be used when you have emergency traffic or need to access the police department for some significant reason.

 When desiring to make a contact, all that is necessary is to indicate that you are on frequency. Give your call, then say "monitoring".

If you wish to call some specific station, give that station's call sign, then your call sign. This may be repeated once or twice. If the other station does not respond, you may be reasonably assured that he is not monitoring the frequency, and further calling on your part will only serve to litter the airways.

- Have consideration for the other 300-plus users --- limit the length of your QSO to the shortest possible amount of time, particularly during the daylight hours up to about 10 pm. Save the longer QSO's for the late-night hours. Best yet, move the other station off to a simplex frequency or another repeater. We want your participation, but please understand that there are many other users......

Remember that this repeater is equipped with a time-out timer set at

approximately two minutes, forty-five seconds.

 Use good operating practice. Remember that there are many listeners outside of the Amateur Community that judge us by the way we conduct ourselves on the air.

 Don't tailgate. Allow a couple of seconds between responses to allow someone else to enter the QSO or move another station off frequency.

Use minimum power necessary to maintain good communications.

If you're "not making it" into the repeater, don't press the issue.

Walt on your call until you are within useable range.

 If you must test your tone-pad on the repeater frequency (or any other testing, for that matter) wait until periods of relative inactivity.
 Avoid testing during the peak daytime periods. Best yet, do as broadcast stations do, and test after Hidnight.

 Remember that the same rules of courtesy and etiquette apply on the radio as they do face-to-face.

CALLING THE REPEATER - is done in the same way as you would call another Amateur Station --- your transmission is begun with your call, and the repeater's call. When you are ready to terminate your traffic to the repeater, give your call, and the repeater's call.

COMMERCIAL TRAFFIC is forbidden by the FCC R & Rs, and the Rules are strictly observed by the Trustee with regards to such traffic. Commercial Traffic is regarded as that traffic which results in monetary benefit to one of the parties involved, or traffic which is directly relevant to one's business. In other words, one may not call to order a pizza, call a service station to provide road service, call one's secretary to check on any calls relative to one's business, and one may not attempt to sell things over the air. One may, however, call someone else and have them palce the call for road service, etc.;:one may call one's secretary and ask her to lunch, or enquire about personal calls. Use discretion; If in doubt, don't do it. All calls are subject to spot interpretation and control by the Trustee.
