MORI MEETING SET - - ELECTION OF OFFICERS SLATED--Please get ready for the most important meeting of the year of MORI this November 6 in Room 12 of the City EOC at 46th and North Eastern. As the newsletter indicated last month, this is the election meeting and we hope that you have your candidates, speeches, and voters lined up for the action. When the smoke clears, then we will know the names and calls of those members of MORI elevated to the status of officers who will guide the club for another year. Bring a friend. It won't be quite cold turkey for the new officers, since the Constitution specifies that they won't take over until January of the next year. Everybody has a warm up period.

16 INCHES OF RAIN IN 4 HOURS OR "HOW I LEARNED TO STOP WORRYING AND PADDLE A BOAT" DEPARTMENT--Hams turned in another fantastic job during the emergency conditions that existed recently in Enid during the flood. On October 10, 1973 in the evening, more than 16 inches of rain fell on the town of Enid and surrounding area in less than 4 hours. A meteorological feat of massive proportions. Enid normally a flat and high area was engulfed in a flood of water, in some cases as much as five to six feet. There were seven lives lost in the incident as tiny creeks and rivers crept out of their banks and covered a five county area. From our perspective, the most important consideration was the fact that Switchboard and all other communications were out. Jack Muse WN5KEZ (newly licensed from the Red Cross classes), director of the Red Cross in OKC called for assistance in reestablishing communications and amateurs all over the area responded to the call. Possibly the yeoman's work was done, of course, by those amateurs in Enid who immediately swung into action. We have had direct reports of assistance provided by K5CAY, Dan, and Ken, W5QMJ who set up on 34/94 in Enid and 22/82 in OKC (WR5ACB repeater). Long range communications on 34/94 was difficult, so it was kept as a local channel and other frequencies were utilized for long haul. WA5JGU, OKC EC reported that he passed or relayed some 15-20 messages during the crisis and estimated the total traffic at over 500. Two professors at OSU activated W5YJ, the club station at Oklahoma State and them and students operated and served as a relay point and eventually net control station for a long period of time. Perhaps the single largest effort (to our knowledge) was turned in by Bill W5UZK in Norman who handled some 145 messages in 14 straight hours after the rain. Bill operated on 3900 khz. exclusively and said that the important factor in the operation was the effort made by the Enid operators John W5BGX, Harold WA5ZOO, Bernie WA5GOE and others who held on for a long time. Of course repeater reception was quite clear, but the range allowance limitation prevented the use of both channels (34/94 and 22/82) at all times. Finally, the assignments of long haul and short haul were made to each channel and relays set up and the operation was in full swing. Bill reported that 3900 was relatively clear except for times when people would tune up direct on frequency!! Needless to say, this is inexcusable. WR5ACB reported that some 12 OKC and surrounding area amateurs participated on 22/82 for the long haul. Some local phone service was restored about 3 days after the flood, but outside service took much longer, over 7 days. The names and calls mentioned in this report are in no way conclusive as to those who participated. Many OKC hams helped, but as usually the real accolades go to those hams in the disaster area who really provide the critical link in such times. A tip of the MORI News Hat to these public spirited citizens who unselfishly worked so hard and diligently.

For the last two months, the monday preceding our meeting has been a holiday, ergo no delivery of mail. Not carefully calculating this into our weekly routine gives us one day less to plan delivery. Newsletters are placed in the mail on late friday or early saturday, but inevitably they arrive the day of the meeting, admittedly not enough time to adequately arrange a schedule to attend the meeting. In addition, while laboring under the mistaken notion that elections were to be held in November (at least it seemed like november!!) I blithly announced the elections in the October newsletter for November! Consulting a Constitution and By-laws showed me the error of this mistaken impression. Fortunately no elections were held at the October meeting and the group decided that it would be prejudicial to hold elections then. since officers don't take office until January, no one will be unduly burdened. So the elections are on for November. In addition, we are enclosing copies of the Constitution and By-Laws of the club in this mail-out so that everyone will be put on notice as to the goings on of the club. Please don't throw them away as they cost money to print. Place them in your files. In addition, we mistakenly listed WB5ECJ as one of the coordinators of the 07-67 maintenance crew when we meant to K5VVZ, Ken. Don't ask me how I did that one. Apologies to Ken.

These classes are a great idea and a great way of centralizing all the efforts of OKC ham clubs to contribute to the growth of our hobby.

PRINTING PRINTED CIRCUITS AT A PRICE YOU CAN AFFORD--Some of us don't have the heavy investment of time and money that it takes to do printed circuit boards right with the photo method and all that. With this in mind (having once been in that boat himself), Roger Ryan, WA5JXX has offered to make boards for people on a limited basis. You supply the art work (Roger says it can be from a magazine or drawings.)He'll shoot a direct positive for you and make a board for the reasonable costs thereof. Not having the costs completely nailed down, Roger said that it might be possible to make a 3" x 6" one sided, glass epoxy, undrilled board for about \$5.00. He can expand as much as 130% or more (but it will cost more) and can use any type of reduction from 4 to 1 on down. The idea is to provide high quality boards for those who occasionally build projects for reasonable prices. Those of you who are already set up could have skipped this section. 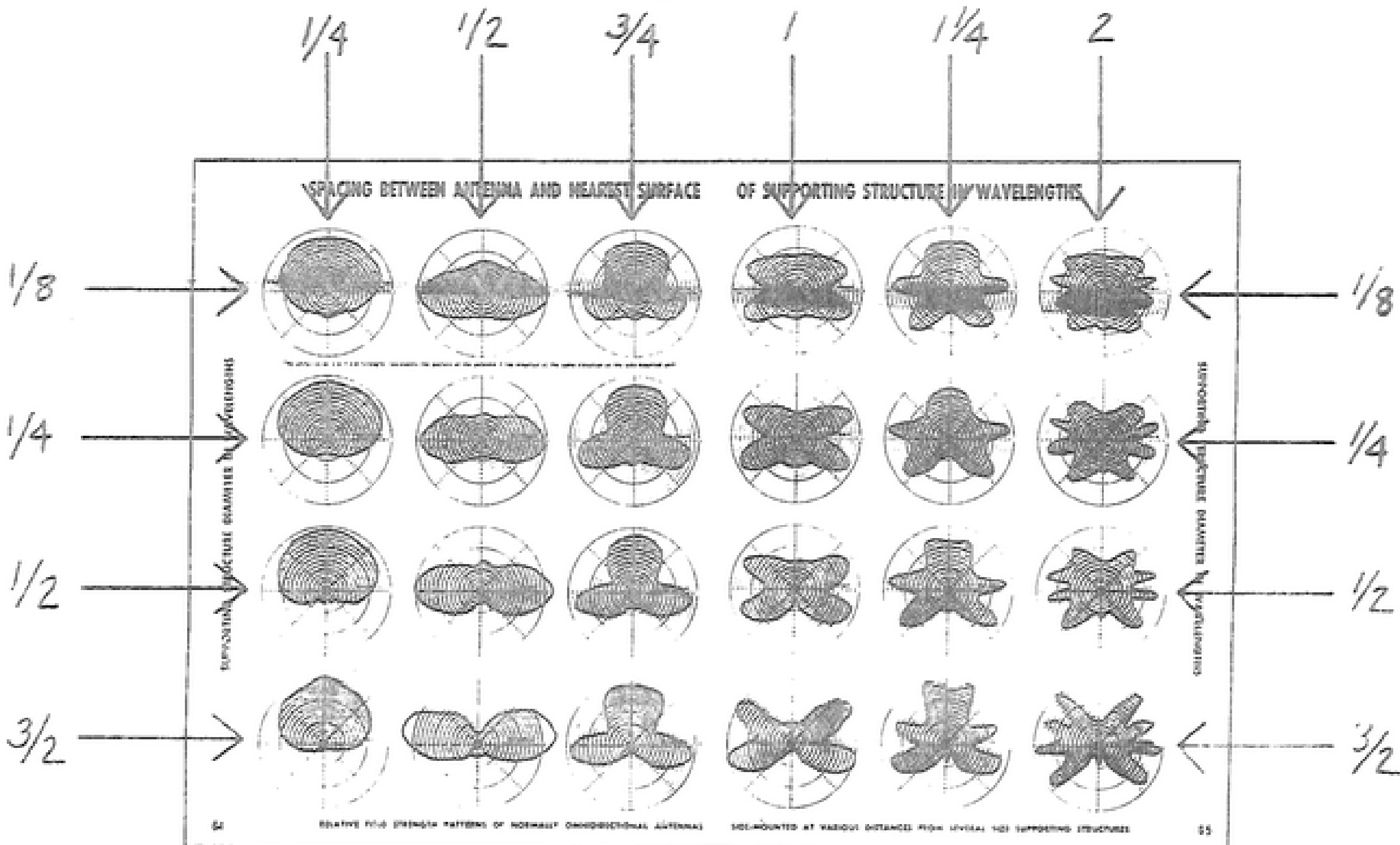

BYLAWS

ARTICLE I - CERTIFICATION OF MEMBERS

Upon receipt of application for membership in the club along with the required dues, the Secretary shall furnish the member with certification of membership in the form of a membership card.

ARTICLE II - OBLIGATIONS AND PRIVILEGES

SECTION 1. Club Obligation: It shall be the duty of each member to support the club with his participation, attendance, time, and money to the extent that he feels obligated to help make a success of the organization.

SECTION 2. Code of Ethics: Each member shall endeavor to abide by the Amateur Code of Ethics to the best of his ability. .

SECTION 3. Privileges: All members are urged to enjoy all privileges of the club as outlined herein and as offered during the existence of the club.

ARTICLE III - DUES AND ASSESSMENTS

SECTION 1. Each member is required to pay annual dues at the time of joining the Club and at the end of yearly intervals thereafter. Dues will become delinquent at the end of the month containing a member's anniversary of joining. The Secretary-Treasurer will maintain a monthly file of membership anniversaries and notify those whose dues are payable during the month of the regular meeting and those whose dues became delinquent since the last regular meeting. Any delinquent member may be reinstated upon receipt of his dues at any time, providing he is eligible for membership. Additional eligible persons residing in the same household may be granted full membership privileges by payment of \$1.00, provided that one member of the household has paid full annual dues. All members of the same household will have the same anniversary date.

SECTION 2. Special assessments may be voted by two-thirds of the membership, provided however, the entire membership is notified in writing the purpose and amount of the proposed assessment at least thirty days prior to the meeting at which the assessment is to be voted upon.

ARTICLE IV - ELECTION OF OFFICERS

SECTION 1. On or about September 1st of each year the Secretary shall notify all members of the club that the annual election of Officers will be held at the regular meeting of the club in October.

SECTION 2. The term of office of any Officer of the club shall be one calendar year, beginning January 1st and ending December 31st.

SECTION 3. Any Officer may succeed himself in office, if elected.

SECTION 4. At the first regular meeting in October, the presiding Officer will accept nominations from the floor. An election will be held and the candidate for each office who receives the majority vote of the members present is elected. Secret ballot will be used.

and mailed to each eligible voting member. The ballots shall include a return self addressed envelope marked to indicate BALLOT. These ballots shall be returned to the Secretary by the deadline stipulated on the ballot, which shall be at least five (5) days preceding the next regular meeting. The Secretary will open the ballots and determine the results of the vote. A two-thirds majority vote of the ballots cast shall be required for approval. If approved, the amendment becomes effective immediately.

ARTICLE XI - CLUB OWNERSHIP RIGHTS

The club shall have the privilege of owning property both real and personal and the right to buy and sell in the club name according to the provisions of the bylaws.

ARTICLE XII - CLUB STATION RIGHTS

The club shall have the expressed right to establish and maintain a club station and establish procedures within the privileges granted by the FCC.

SECTION 5. Nominees for office shall give their approval before becoming candidate for office.

ARTICLE V - DUTIES OF OFFICERS

The duties of the Officers shall be such as their titles, by general usage, would indicate. Specifically, the President shall preside at all meetings. He is an ex-officio member of all committees. He is the spokesman for the club at all official functions. The Vice President's duties shall be to take over the duties of the President in the absence of the President. He shall have all the authority of the President when acting in the Presidential capacity. He shall assist the President in all activities and purposes of the club. The Secretary-Treasurer's duties shall be to keep the minutes of each meeting. He will collect the dues as prescribed in the bylaws and keep an accurate record of the financial standing of the club. He will be held personally responsible for the funds entrusted to him and give an accounting to the club on request.

ARTICLE VI - TRUSTEE

The Trustee Office shall be filled by Wayne Hogan, WA5AOB, charter member of the organization, until such time that he or the club by majority vote at any regular meeting, determines that the office be filled otherwise.

ARTICLE VII- DUTIES OF TRUSTEE

The Trustee shall be charged with the responsibility of caring for the physical property of the club, as well as acting in the name of the club in matters that may require official Trustee action, with the approval of the governing body.

ARTICLE VIII - VACANCIES

SECTION 1. A vacancy in the office of the President shall be filled by the Vice President.

SECTION 2. A vacancy in the office of Vice President or Secretary-Treasurer shall be filled by a majority vote of the members present at a regularly scheduled meeting or at a special meeting.

ARTICLE IX - COMMITTEES

SECTION 1. An executive committee shall be established as a standing committee. This committee shall consist of the Vice President, Secretary-Treasurer, and three other full members appointed by the President, subject to the approval of the membership present at any regular meeting. Duties of this committee are to act for the Club under provisions of Article XI of the Constitution and Article XIII of the bylaws.

SECTION 2. Special or standing committees may be appointed by the Presiding Officer at regular or special meetings that may be necessary. Committees may be appointed when necessary or advantageous to the club.

ARTICLE IV - MEMBERSHIP PLEDGE

Each member shall pledge himself to adhere to the best of his or her ability to:

- a. All applicable FCC rules and regulations.
- b. The requirements of this Constitution.
- c. The Bylaws.
- d. The code of ethics adopted by the club.

ARTICLE V - VOTING PRIVILEGES

All full members and charter members shall have full voting privileges providing they are not delinquent in their dues.

ARTICLE VI - EXPULSION

Members of the club may be expelled in accordance with such procedure as may be established in the bylaws for violation of this Constitution, violation of the code of ethics of the club, or for other conduct which would tend to cause discredit to fall upon the club or upon amateur radio as a whole.

ARTICLE VII - RESIGNATIONS

Any member has the prerogative of resignation from membership in the club and any resignation will be recognized and accepted when submitted to the Secretary in writing.

ARTICLE VIII - GOVERNMENT

The government of the club shall be vested in: (a). The Officers of the club who shall be nominated and elected in such a manner as may be prescribed in the bylaws. The Officers shall be a President, a Vice-President, and a Secretary-Treasurer. The Trustee position shall be filled as may be prescribed in the bylaws.

ARTICLE IX - MEETINGS

SECTION 1. Regular meetings shall be held at the place, and on the date, and at the time as determined in the manner prescribed in the bylaws, and shall be presided over by the President or succeeding Officers. A Quorum shall consist of 20% of the paid up membership.

SECTION 2. Special meetings may be called for any purpose by an Officer of the Club who shall preside over the meeting. A Quorum shall consist of 20% of the paid up membership.

ARTICLE X - AMENDMENTS

This Constitution may be amended in the following manner:

- a. Any proposed amendment shall be first presented at any regular or special meeting for approval.
- b. If approved by a majority vote of the members present, it shall be submitted to the entire membership for final approval.
- c. The proposed amendment shall be put in writing by the Secretary

ARTICLE X -- MEETINGS

SECTION 1. Regular monthly meetings shall be held during the first full week of each calendar month at a time and place announced by the governing body. Notification of the membership will be by the best means available under the prevailing circumstances. Selection of the meeting place shall be the responsibility of the governing body.

SECTION 2. Special meetings may be called as prescribed in the Constitution and the date, time, and place likewise designated. Notification of the membership will be by the best means available under the prevailing circumstances.

SECTION 3. ROBERT'S RULES OF ORDER, latest edition, shall be recognized as the authority of procedures governing any regular or special meeting, when not in conflict with the Constitution and these Bylaws.

ARTICLE XII - EXPULSION

SECTION 1. A member may be expelled from membership in the club in the following manner:

- a. Proposed expulsion of a member shall be openly discussed at a regular meeting or special meeting and reasons for expulsion explained.
- b. The Secretary shall notify the affected member at least seven (7) days in advance of the next regular or special meeting, at which time a vote of the members shall be taken.
- c. Any member who becomes delinquent in the payment of his dues to the club for a period of twelve (12) months shall be automatically dropped from the roll.

ARTICLE XII -- CODE OF ETHICS

A Code of Ethics, modeled after the code of ethics of the ARRL, to be used and adhered to by members of the club, shall be prepared and approved by the club.

ARTICLE XIII - OWNERSHIP AND TRANSFER OF PROPERTY

The club may own property as provided by in the Constitution. Any purchase or sale of club property must have the approval of the majority of the members present at a regular or special meeting. This does not exclude the Trustee from making or authorizing others to make repairs to the station equipment to keep it operational. The operating budget of the Trustee will be approved by two-thirds of the membership.

ARTICLE XIV - AMENDMENTS

These bylaws may be amended by a majority vote of the members present at any regular or special meeting.

CONSTITUTION

ARTICLE I-NAME

The name of this organization shall be MID-OKLAHOMA REPEATOR, Inc., a non-profit organization hereinafter referred to as the club.

ARTICLE II - OBJECTIVES

The objectives for which this Club is organized are:

1. To render a public service to governmental agencies during impending storms or severe weather, as well as to assist in disaster relief operation and other community functions as required.
2. To unite the amateur radio operators of this area for the purpose of exerting effectively a combined influence upon matters concerning amateur radio operation.
3. To promote good operating procedures and the exchange of technical information and assistance.
4. To stimulate adherence to a code of ethics, both written and understood.
5. To admonish members to comply with existing FCC rules and regulations.
6. To be an influence to new amateur operators of the area in the operation of their station.
7. To promote good will and fellowship among the members.
8. To further the art of electronics and encourage prospective members to participate in the purposes of the club.

ARTICLE III - MEMBERSHIP

SECTION 1. Eligibility for membership in the club is set forth as follows:

Any person is eligible for FULL MEMBERSHIP provided that;

- a. He holds a valid Amateur Radio Operator/Station license.
- b. He indicates a desire to become a member.

Any person who was included in the original organization of this club will be considered as a CHARTER MEMBER.

SECTION 2. To become a member of the club a person who is eligible must furnish his name, address, call sign, telephone number (if any), and annual dues to the Secretary.

SECTION 3. HONORARY MEMBERSHIP may be bestowed on any eligible person by majority vote of members present at any regular or special meeting. Honorary membership shall be for not more than one year duration. Honorary membership will not have voting privileges.
